- Sold 1** Adjusted +3300 for GLA. Somewhat greater flow of traffic is present and with it there is more noise from traffic. Wear and tear seems to appear more apparent to the property with some maintenance advised
- Sold 2** General property maintenance is consistent with the neighborhood with average to normal wear and tear. Traffic and noise from traffic is minimal.
- Sold 3** Adjusted -9250 for GLA. Neighborhood is noticeably quieter than surrounding area with fewer cars and foot traffic. Greater care and attention to detail to property maintenance is evident
