All comps are located in the subject's general neighborhood and are recently closed. Appraiser choose the best comps available. Per online photos comp 3 is superior in condition/quality. Most weight is given to comp 1 for its similarity.

EXPLANATION OF ADJUSTMENTS

Amenity differences have been adjusted properly and are deemed customary for the area. Net/gross adjustments are within the standard 15%/25% guidelines. No negative external factors were noted which would negatively impact marketability. Value appears to be adequately supported.

Reconciliation Summary

After reconciliation of the supplied comparables, a value estimate of \$550k considered reasonable as of 12/27/21. 



This Appraisal Report was performed by a Licensed or Certified Real Estate Appraiser to estimate the market value of the subject property being evaluated as of the effective date of value stated. Clear Capital has provided the appraiser with additional preliminary data resources for consideration in the analysis, which may include: Property Inspection, MLS records, and Public Records. Although the appraiser did not physically inspect the subject property, at a minimum the appraiser has considered the results of a recent visual property inspection completed by Dannielle Carnero, a licensed real estate agent having completed the above referenced Property Inspection.
