<p>I went back 3 months, out in distance .25 miles, and was able to find 1 sold comps of which I could use that fit the requirements. I had to go out in distance .5 and found 2 sold comp of which I could use that fit the correct requirements. I went out in distance 1 mile in similar neighborhood with same market values and found 3 active comps of which I could only use due to low or zero inventory factors. The comps used are the best possible currently available comps within 1 mile and the adjustments are sufficient for this area to account for the differences in the subject and comparables. There are more buyers than listings. Most sellers are receiving multiple initial offers over asking price due to low or zero inventory. The market isn't driven by REOs.</p>

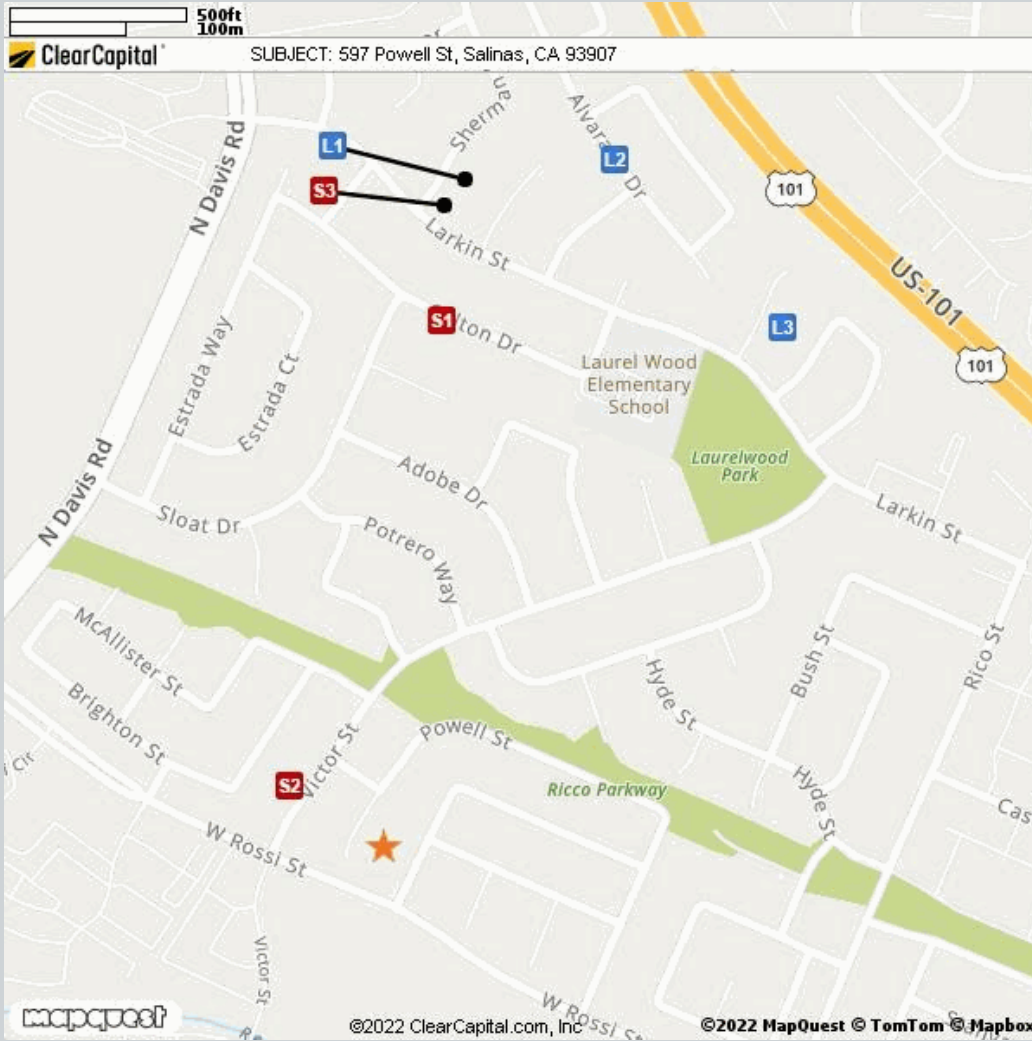
