Comments Regarding Pricing Strategy

Subject bed count is unique for the neighborhood. To locate comparables in closer proximity of subject, it was necessary to exceed bed count guidelines. Within 0.50 mile, 20% GLA +/-, Year built 20 +/- and 12 months back, there were limited comparables available in the subject neighborhood. Therefore it was necessary to exceed the style, closed date, bed/bath count, year built, lot size guidelines and proximity up to 1 miles. In order to use proximate comparable, it was necessary to use comparable having variance in condition. Most of the similar comparable in the subject neighborhood is renovated or having updates, Due to limited availability of similar conditions comparable, I was forced to use compared with some minor upgrades. Sale #3 exceeds 5 months on date of sale but used due to stable market conditions. Subject is located near commercial building and busy major roadways. This will not affect the market ability of the subject. Also since there were limited comps in the same side of the subject it was necessary for me to cross highways to get enough comps. This will not affect the market ability of the subject. In delivering final valuation, most weight has been placed on CS1 and LC1 as they are most similar to subject condition and overall structure.

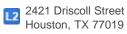

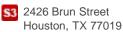

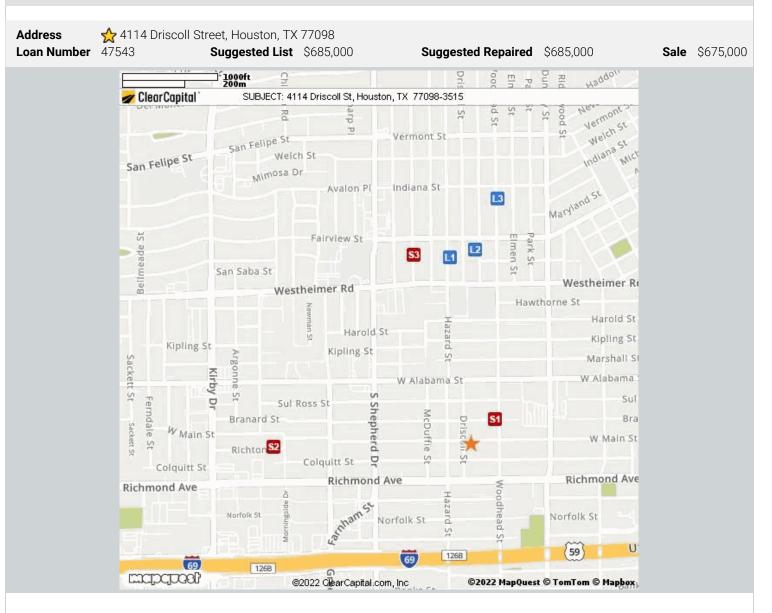
