The sold comparable listings moved off the market within what is typical for this area which allowed the final pricing for the subject to be set more aggressively to encourage the desired marketing period for a fair market value as requested in this report.</p>

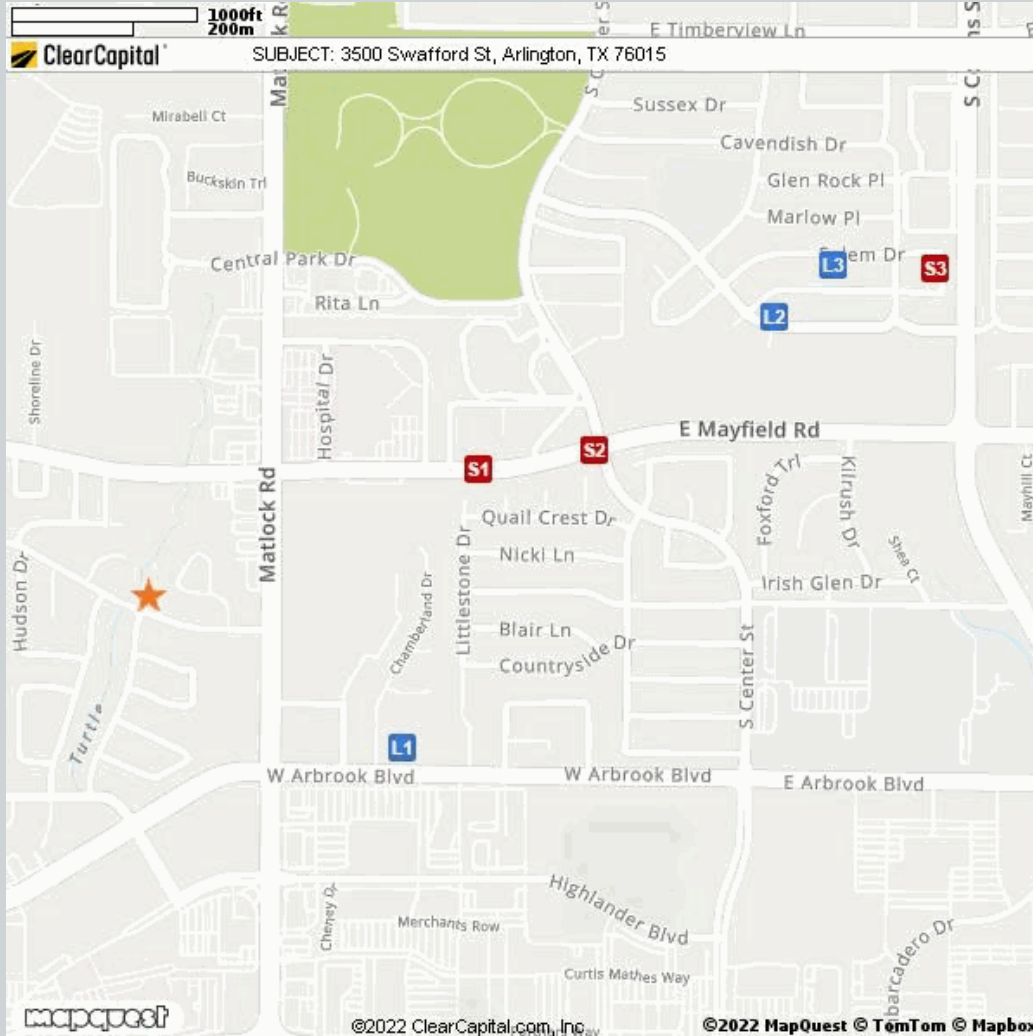
