<p>The subject is a 2 story SFR in average condition and details are taken from tax record. Due to limited comparable availability, it was necessary to use comps with difference in the sub-style, pool, condition and to expand lot size tolerance in order to locate comps supportive of the subject GLA and other attributes. To maximize the accuracy of initial valuation, I have elected to increase the time span of closed sales past the favorable 3-month window to find comparable that required the fewest net adjustment. The subject is located within reasonable proximity to highway, park, worship center, commercial centers and location characteristics will not affect its marketability. In delivering final valuation, most weight has been placed on CS3 and CL1 as they are most similar to subject condition and overall structure.</p>

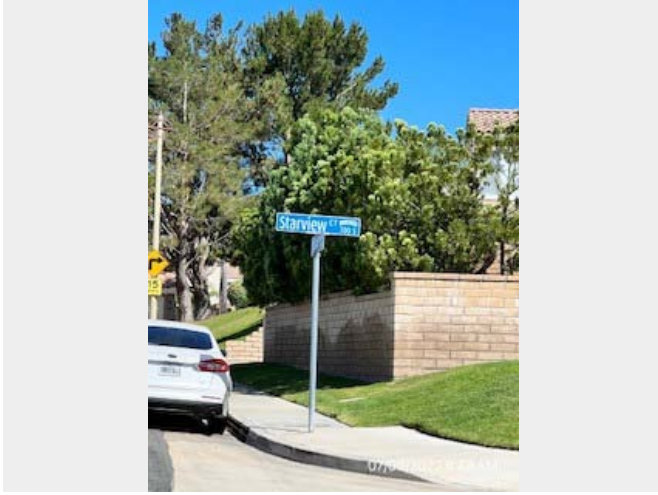

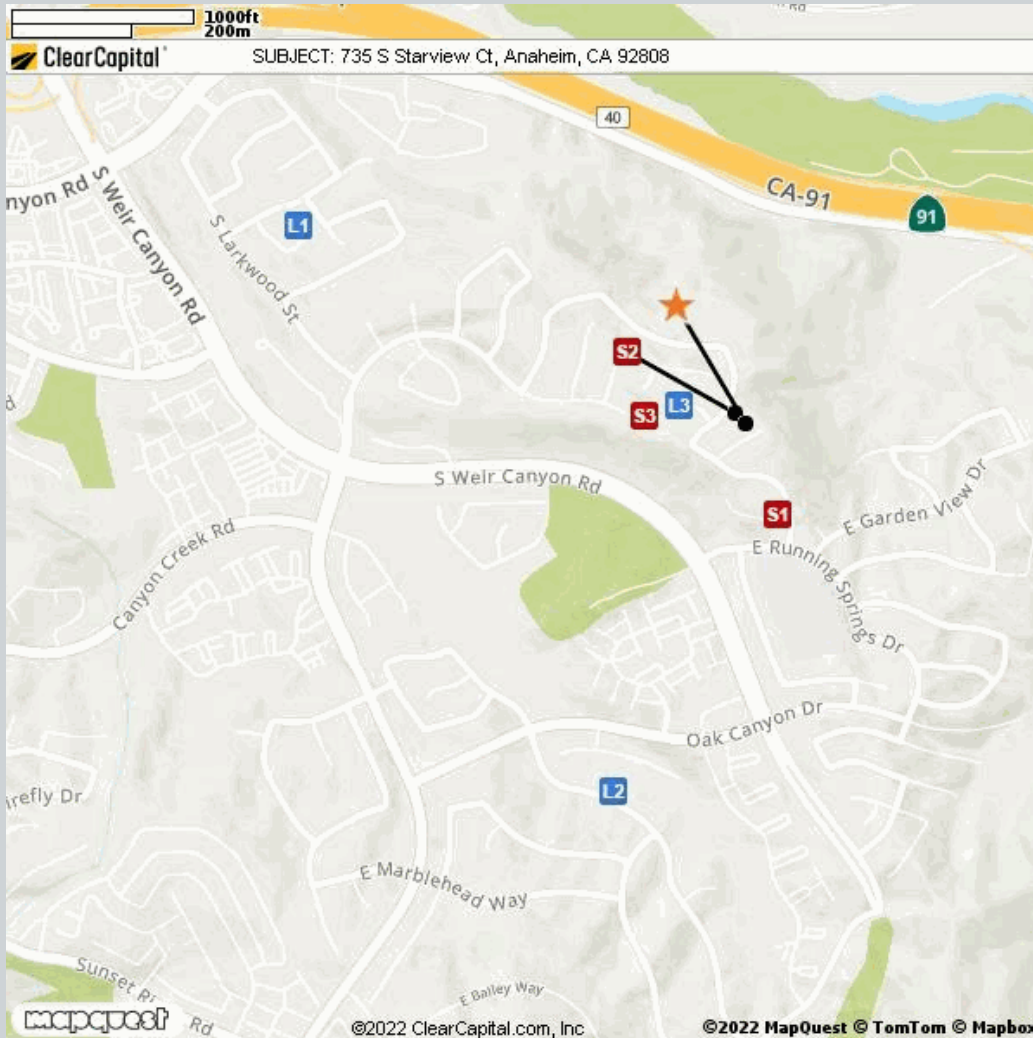
