<p>The subject is single family SFR Ranch with GLA 1594, bed count 3, bath count 2 and was built in the year 1954. All maintenance appears to be up to date and no repairs are necessary based on the exterior inspection. All necessary amenities and public transportation are located within close proximity to the subject. There was no functional or economic obsolescence observed. I exceeded the style, year built, bath count, pool, garage count and lot size due to very few comps availability. Only few comps were available within one mile. Therefore I had exceeded the proximity to 3 miles and GLA to +/-30%. The value and marketability will not be affected with the subject being located near highway, railway track and commercial area. Comparable crossed neighborhood railroad tracks and highway. This however, will not have effect on value and marketability. The comps were still valued correctly and is an accurate reflection of the local market value. More weight has been given to CS2 and LC2 which are similar in GLA and maintaining the overall value and structure related to the subject. Subject attributes are taken from the tax record.</p>

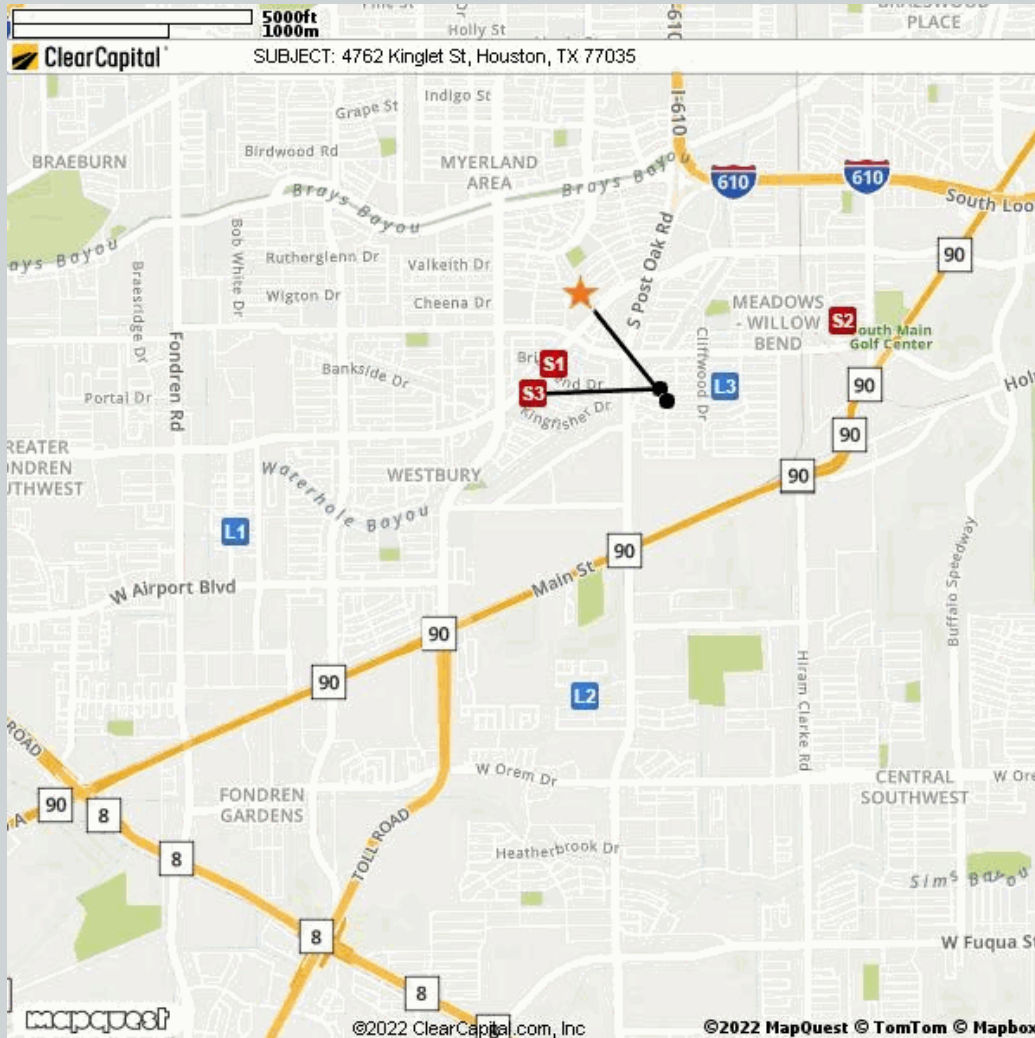
