<p>The subject property is a single family home, which is in overall average condition on the exterior. The exterior of the subject property does not appear to be in need of major repairs. Comps were searched for within a distance of 1 Mile and back 6 months in time. It was necessary to search beyond 3 months time for sold comps as there were limited recent similar sales in this area. The GLA Tolerance searched for similar comps was +/- 20% of the subject's Sq. Ft. The subject is in average exterior condition and priority was given to locating comps which are in average condition. Market conditions and home prices are increasing within this area due to continued strong demand and limited inventory of homes for sale. The subject property did not appear to have any major negative site influences.</p>		

## Clear Capital Quality Assurance Comments Addendum

**Reviewer's Notes** The price is based on the subject being in average condition. Comps are similar in characteristics, located within 0.98 miles and the sold comps closed within the last 5 months. The market is reported as having increased 15% in the last 6 months. The price conclusion is deemed supported. The broker's as-is conclusion reflects the market for the subject. 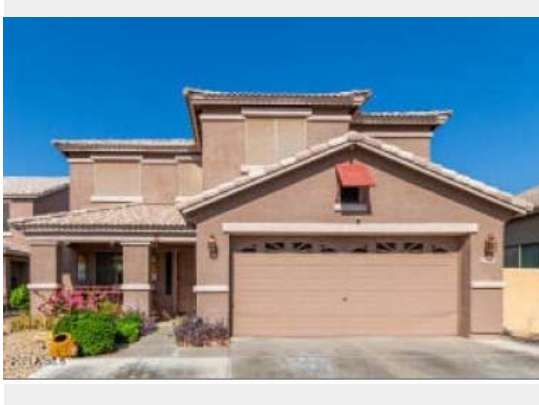

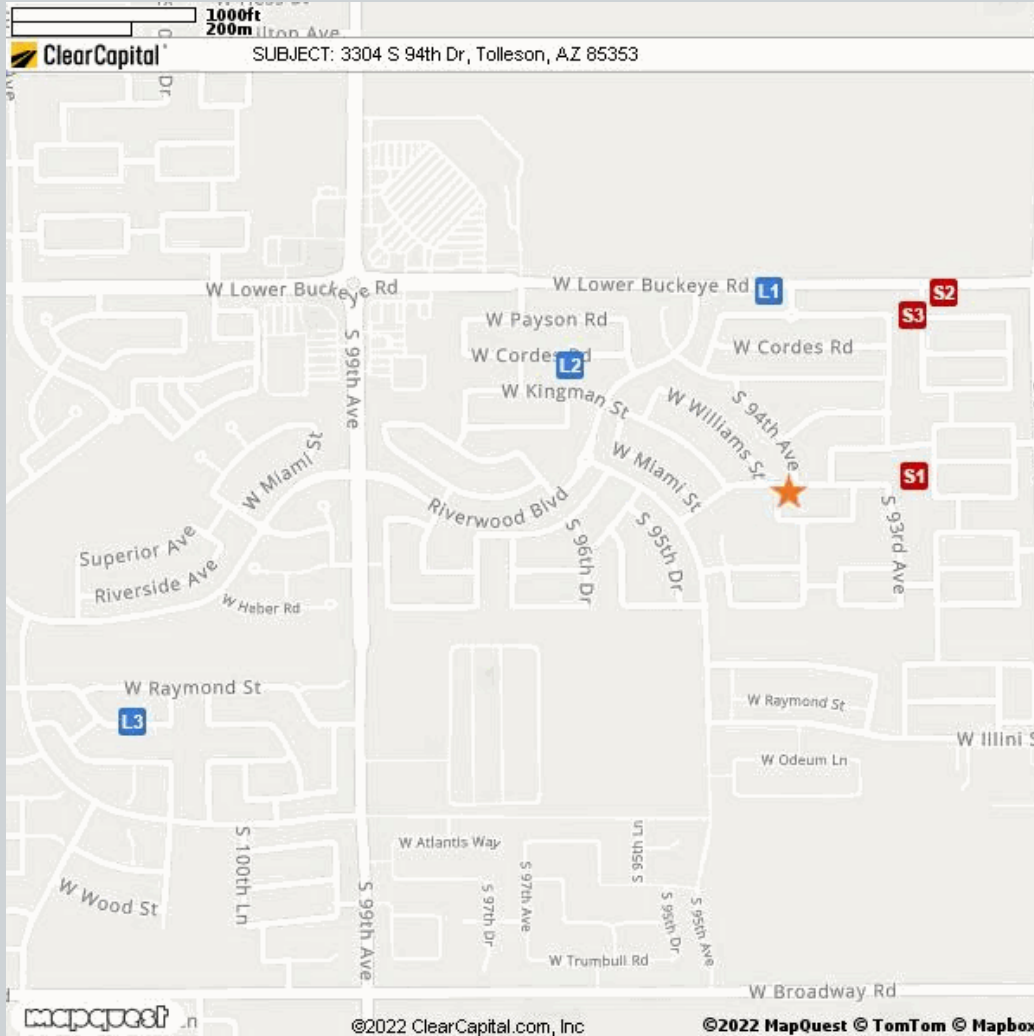
