<p>Subject is 1971 Sq.Ft house. Due to limited comparables, need to exceed bed/bath count, sold date up to 12 months, proximity up to 4.7 miles, bed/bath count and lot size guidelines. Since limited comparables were available, need to take comparables with closed date beyond 3 months. To stay in closer proximity need to use good condition comparable. In order to support the subject's GLA, it was necessary to use comparable that differed from the subject's view. Subject is located near busy road, worship area, highway, school, cemetery, commercial amenities, park, water bodies, commercial amenities. Due to limited comparable from same location, it was necessary to use comparables from across the major roadways. However, this won't affect the market value. The comparables selected were considered to be the best available. In delivering final valuation, most weight has been placed on CS1 and LC2, as they are most similar to subject condition and overall structure. Subject attributes are taken from Tax record. Garage count is verified using MLS.</p>

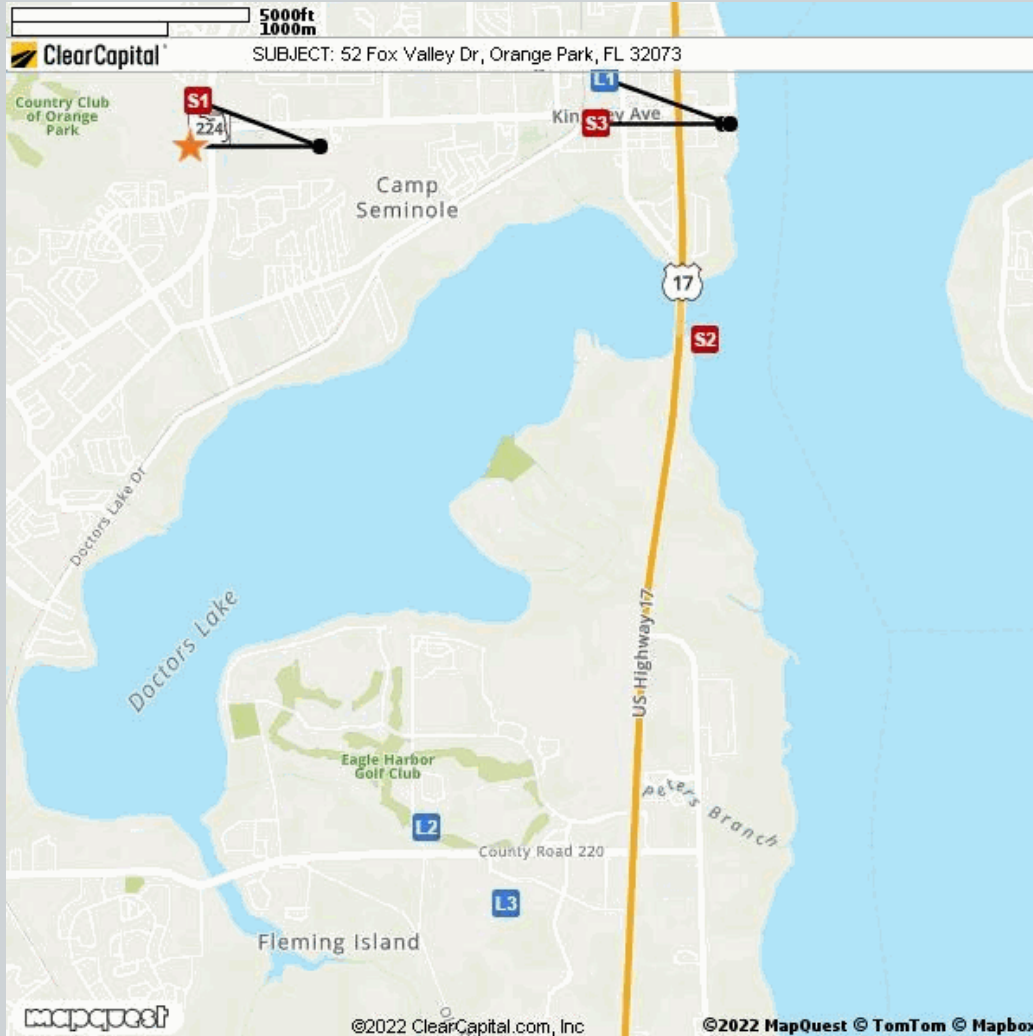
