Within 2 miles and back12months I found10comps of which I could only use3due to lot size factors. The ones used are the best possible currently available comps within2miles and the adjustments are sufficient for this area to account for the differences in the subject and comps</p>

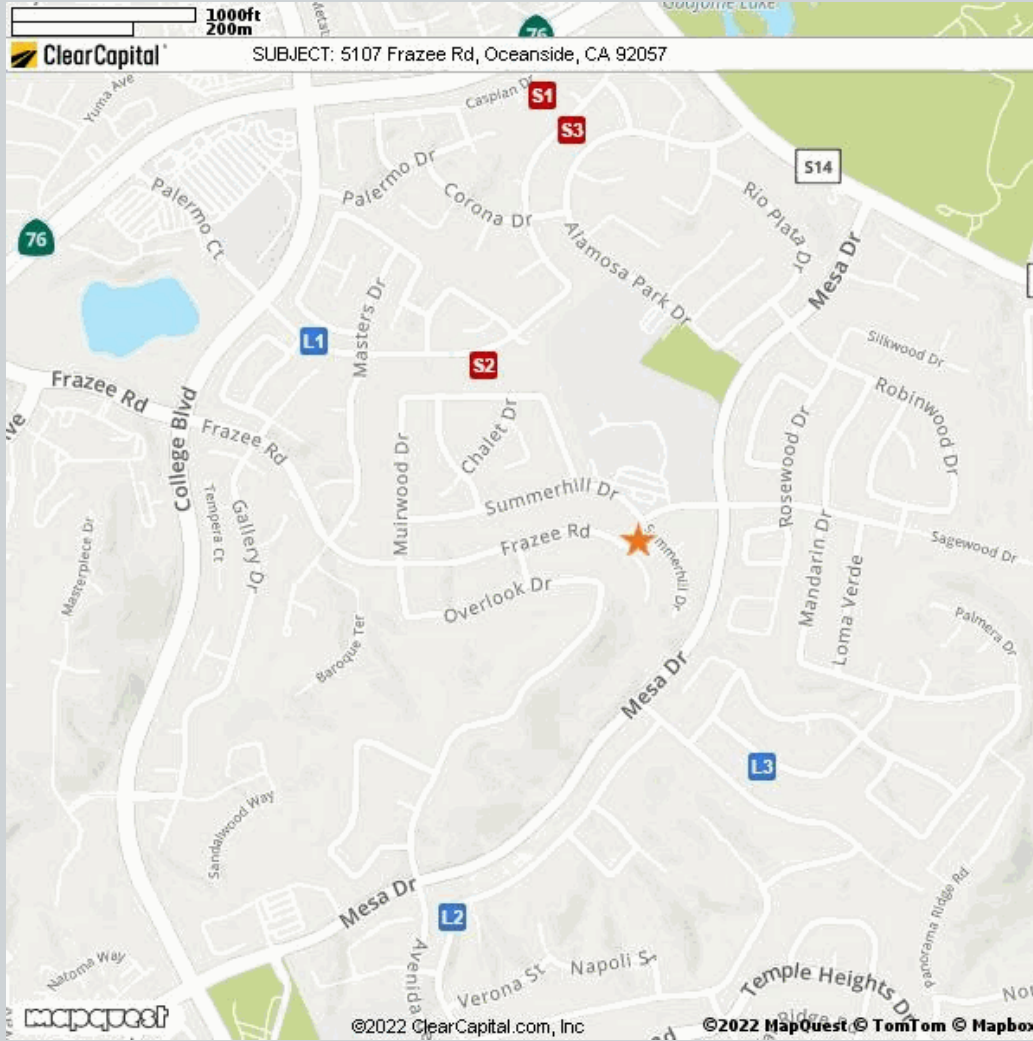
