<p>Our market is still increasing but at a slower rate than we've seen in the past year- SFR increased 20.9% in sales price since this time last year. Inventory remains less than a month supply, although we have seen more homes hitting the market lately. Distressed sales are still low, accounting for only 0.3% of sales. Cash sales account for about 47% of recent sales. Days on market are also low- roughly 96% of homes sell within 60 days. The suggested list price is based upon comparable sales used in account with current market conditions. Also based on exterior inspection only- interior condition could dramatically affect the value of the property.</p>

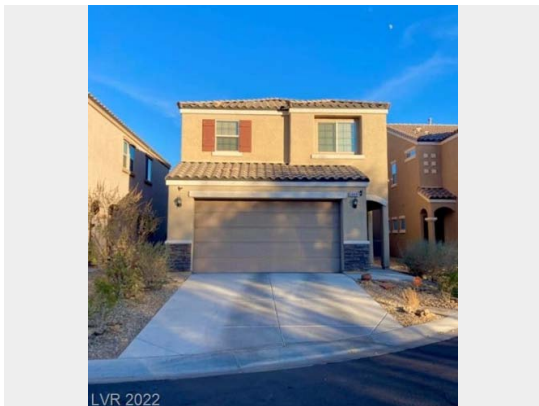

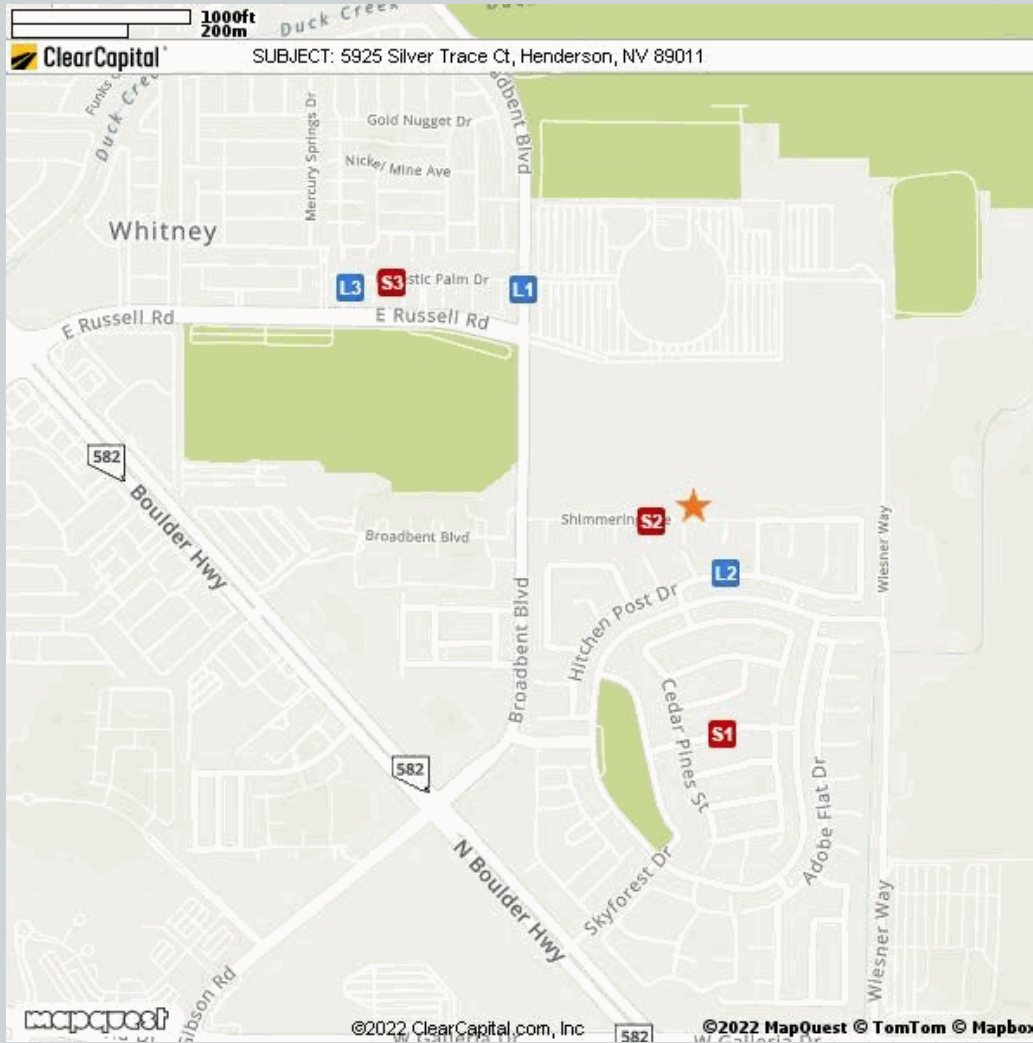
