Prices are based on most recently closed sales similar to subject and currently listed properties in direct competition with subject property. Home was priced at mid-value since there are no extraordinary characteristics that would value the subject lower or higher. Due to limited available market data for similar properties in the subject's immediate neighborhood, it was needed to expand proximity to acquire comps. It was also needed to use comps that varies in design/style, GLA, lot size, year built and room count. The properties used are the best possible currently available comps within 0.99 miles. The adjustments are sufficient for this area to account for the differences in the comparables to accurately reflect the current market prices of the subject.</p>

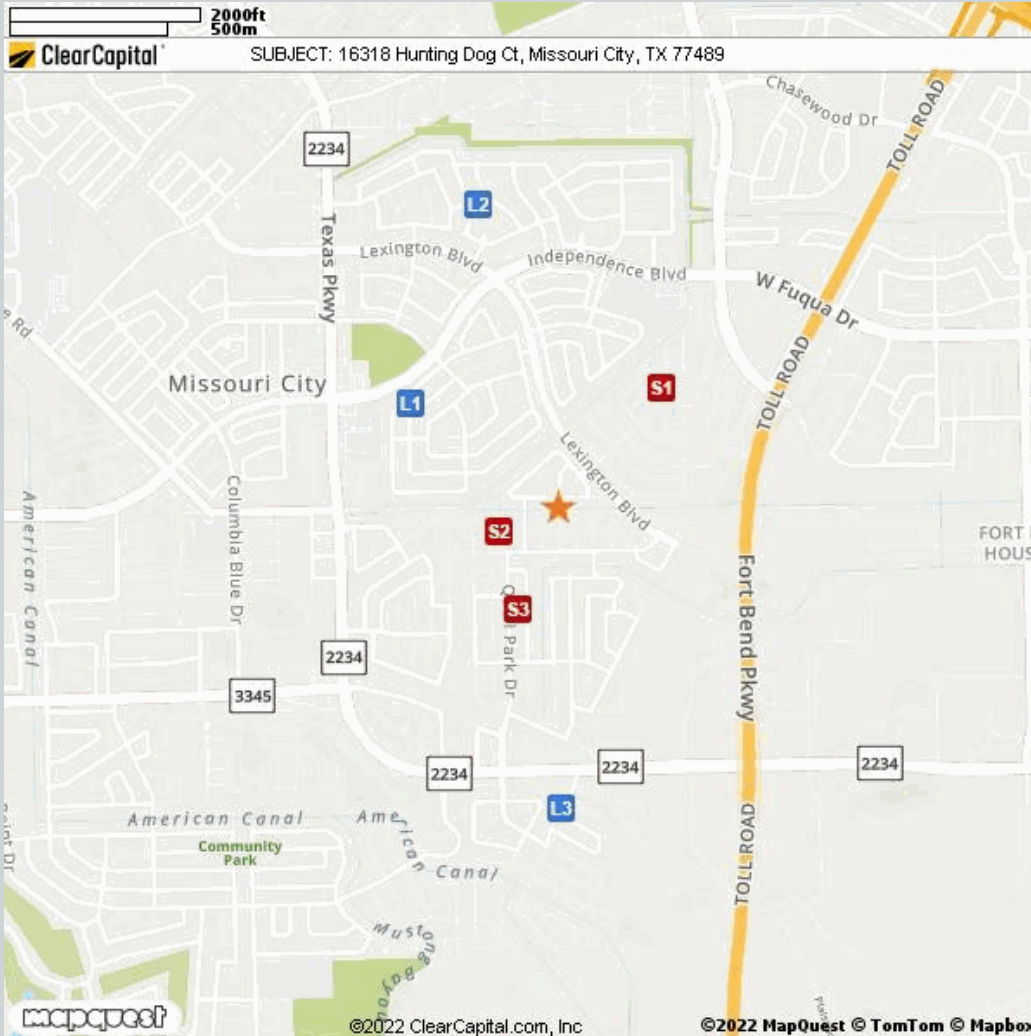
