Reasons for Adjustments Why the comparable sale is superior or inferior to the subject.

- Sold 1** It is inferior because of having a smaller GLA and for having a smaller lot. Overall, similar in design and appeal and has comparable views. Also farthest in proximity to the subject compared to other comps used. Adjustments: \$1500 due to sq ft, -\$1238 due to the lot, -\$1800 due to age, \$3000 due to no 2 carport.
- Sold 2** Shows the best support from my value conclusion. Overall, it has the most comparable characteristics and most importantly the most similar location/view which is one of the biggest factors with the subject. Adjustments: \$420 due to sq ft, \$1400 due to age, \$3000 due to room count, \$5000 due to no 2-car garage, -\$10,000 due to updates, -\$10,000 due to 2 workshops.
- Sold 3** It also has the same view as the subject, but its larger GLA and updates make this superior to the subject. Therefore my value conclusion most aligns with Sale 2. Adjustments: -\$555 due to sq ft, \$165 due to the lot, -\$1000 due to age, \$3000 due to no 2 carport, -\$30,000 due to updates.

<p>Note: Commercial Influences, freeway, and a school in the immediate vicinity of the subject will not negatively influence the marketability and value of the property. The comps below were considered but because they reflected a value very different than the rest of my comps, they were replaced with comps that better supported the market and my final value conclusion. Sales: MLS #7684029/7455 Leaflex, Sales: MLS #48761081/14826 Hickorytex, Sales: MLS #34500089/15331 Flamingo Park The search was extended back 6 months, out in distance 2 miles, and even with relaxing 35% GLA search criteria I was unable to find many comps that fit within 20% GLA requirements and similar style and appeal. Within 2 miles and back 6 months, I found 12 comps of which I could only use 6 due to condition or site-size factors. The comps used are the best possible currently available comps within 2 miles and the adjustments are sufficient for this area to account for the differences in the subject and comps. Upon review of all the pertinent information, an opinion of the as- is market value of \$165,000 is adequately supported with emphasis placed on List No. 2 and Sale No. 2. Based upon an exterior inspection, from the street, the subject property has no observable adverse condition noted that would cause a safety or health risk/concern at the time of inspection. Therefore no resale issues are foreseen.</p>

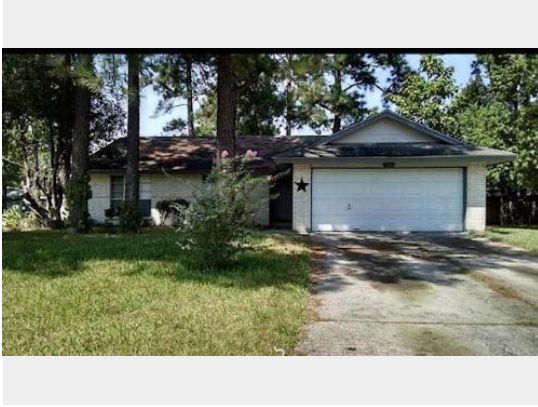

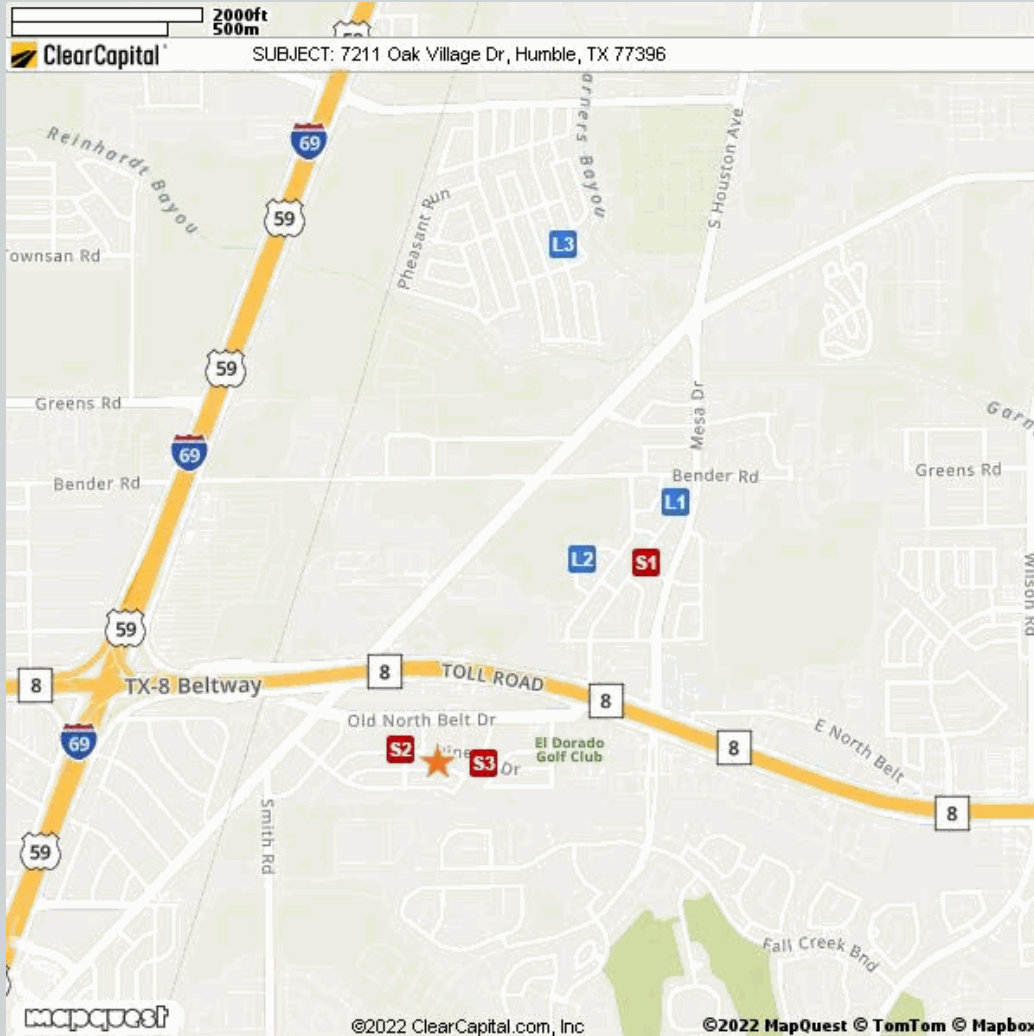
