Comps used are different styles due to the lack of recent market activity, used most similar found. Proximity to the highway and commercial would not affect subject's marketability and both sides of the highway and commercial are similar market areas. List 3 Comp were weighted the most and similar in bedrooms and close proximity. Sold comparable 2 was weighted the heaviest due to GLA.</p>

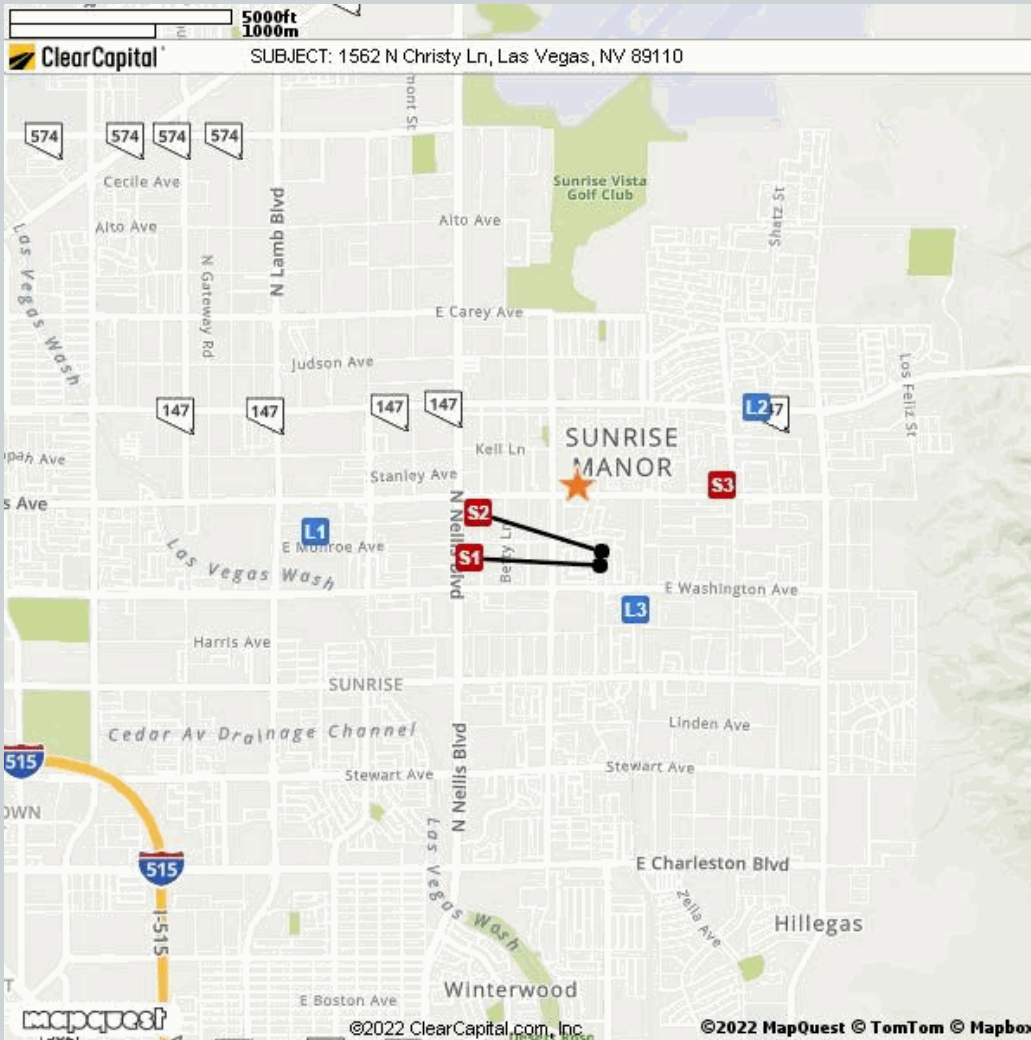
