The following parameters were used: MLS area Stockton, 0.500 mile radius, back 6 months in time, dwelling square footage ranged from 1082 to 1622 sq. ft., the year built ranged from 1969 to 1979. The search returned 4 sale and 0 active/pending listing. Due to a lack of recent activity, the comparable search parameters could not be meet. Search parameters were expanded up to 1 mile on distance, regardless of size and age. The most recent relevant comparable were used in this report. Currently, the subject's immediate and general markets are experiencing stable or increasing values in some neighborhood. Some neighborhoods are still very sought with less supply available. 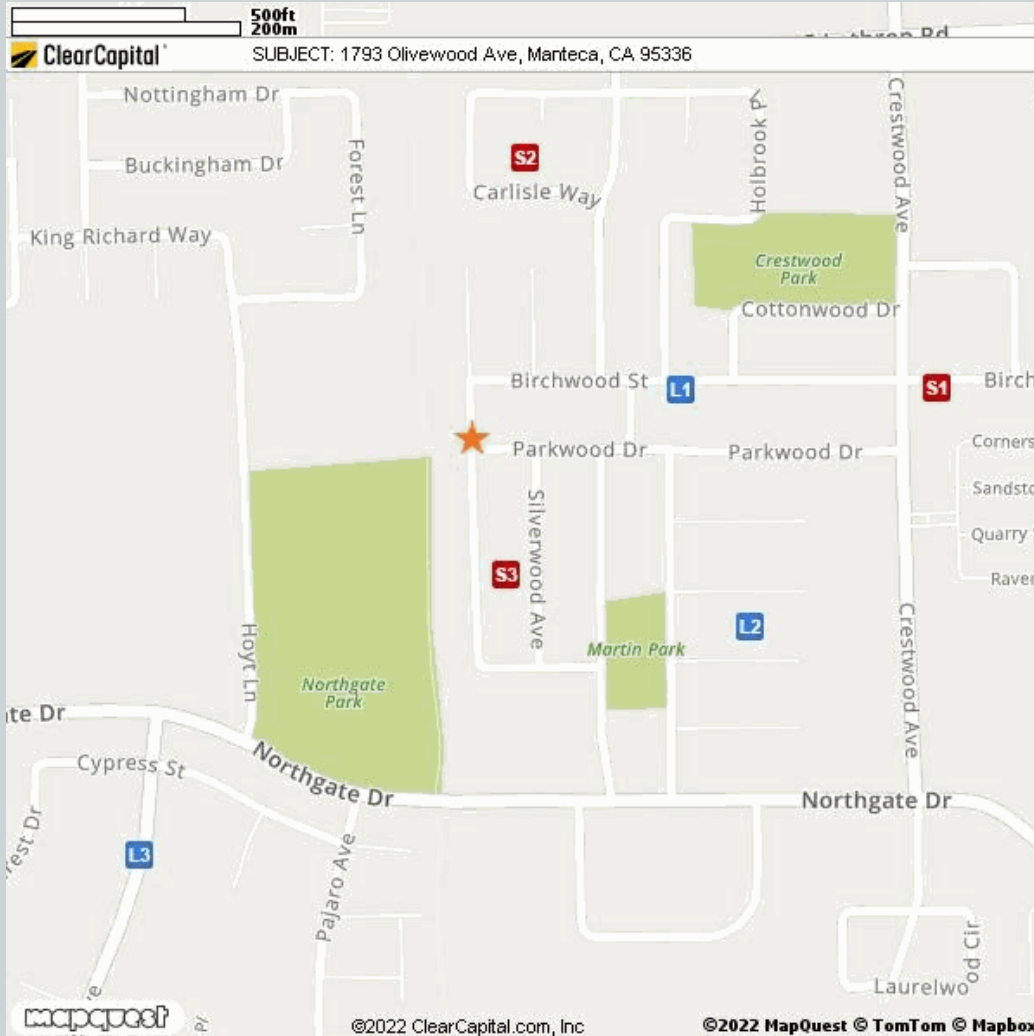
