Most of the similar comparable in subject neighborhood are renovated or having updates Due to limited availability of similar condition comparable, I was forced to use comparable with some minor upgrades. The subject is located close to commercials, parks, school and busy street but this will not affect the value of the subject as the comps used in the report also have similar location factor. In delivering final valuation, most weight has been placed on CS2 and LC2 as they are most similar to subject condition and overall structure. Market values remained stable during last 12 months within subject's market area. Subject details are taken from external sources..</p>

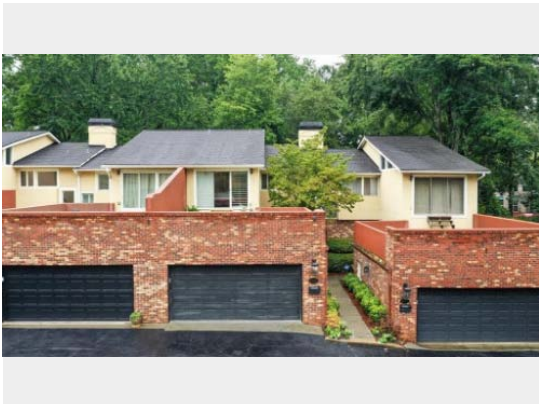

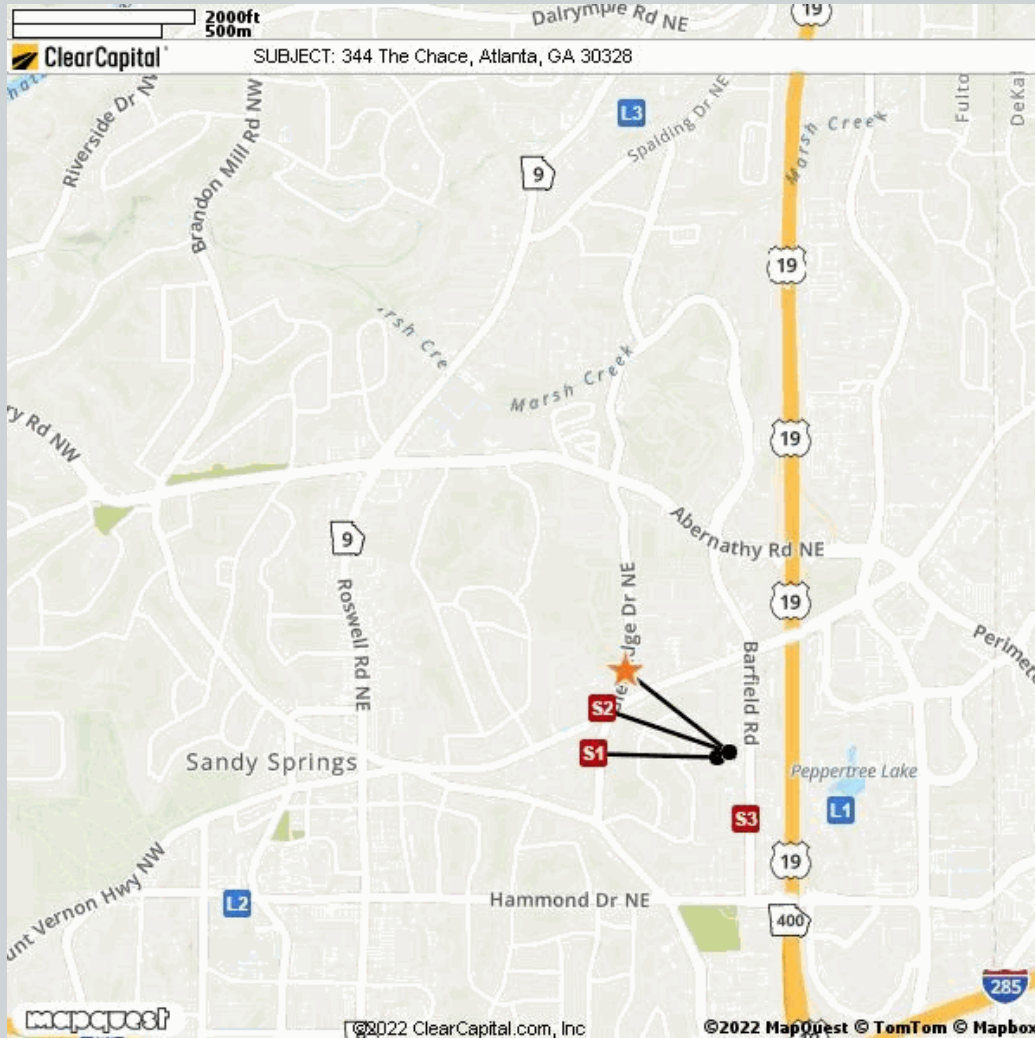
