<p>The subject is a SFR style in average condition and no upgrades have been made to the subject. Based on the exterior observation the subject appears to be in average condition and no negative features. As long as the subject is priced within the market value of the most recent similar comps within the subject property's area there should not be a problem with resale. Within 1 mile, 20% GLA +/-, Year built 20 +/-, there were many comparable available in the subject neighborhood. Therefore it was necessary to exceed the closed date, condition, year built, garage guidelines. The comparable selected were considered to be the best available. In delivering final valuation, most weight has been placed on CS2 and LC1 as they are most similar to subject condition and overall structure. The subject property has commercial properties and public infrastructure nearby. The surrounding area has all necessary highway, school, railway track and commercial within reasonable distance. But it won't affect the market value. The details were taken as per the tax record.</p>

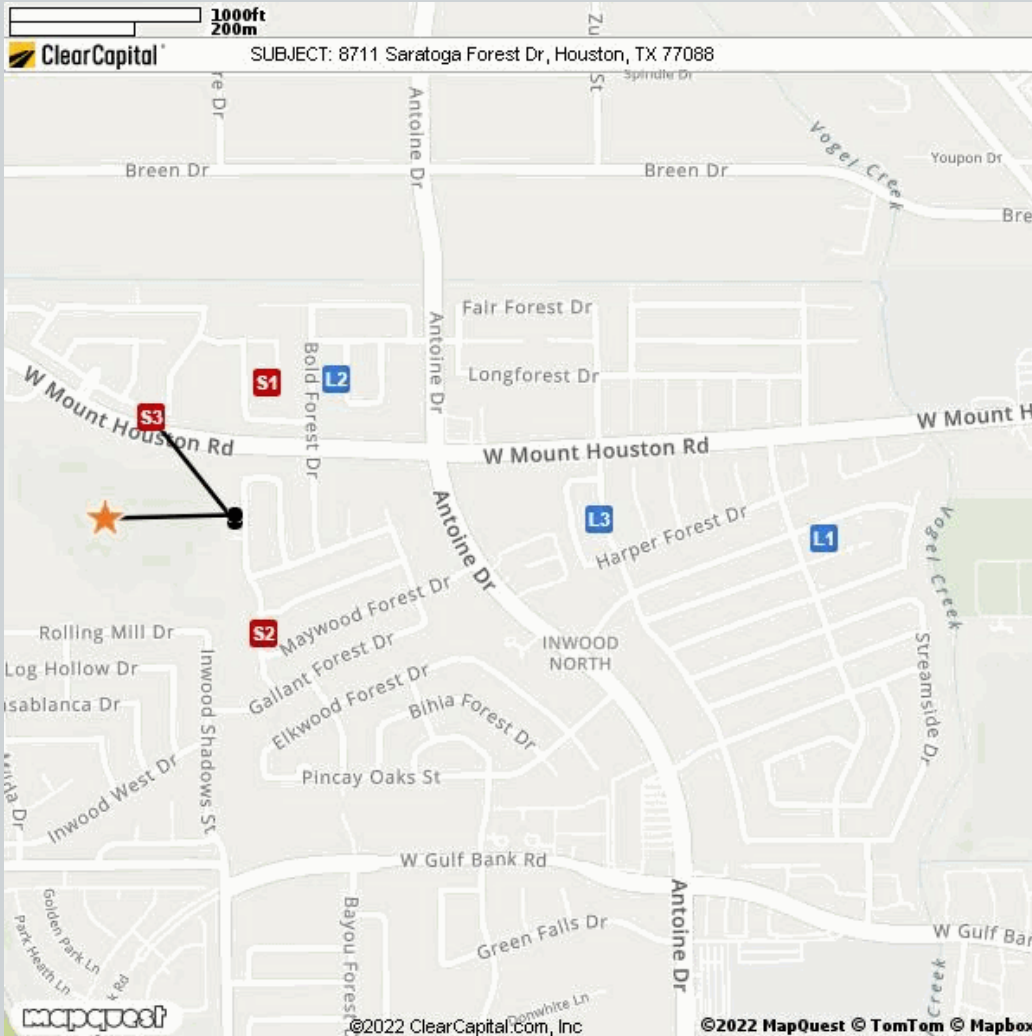
