<p>The subject is an SFR with GLA 1085 sq ft. In order to stay within 1 mile proximity, it was necessary to exceed lot size by +/- 30%, GLA by +/- 30% and bed/bath count. Since there were only limited comparable available I was forced to use comparable with inferior bed/bath count. The subject seems to locate near highways, parks and commercial space, this does not have any impact on current market value. In delivering the final valuation, the most weight has been placed on CS2 and LC2, as they are most similar to subject conditions and overall structure.</p>

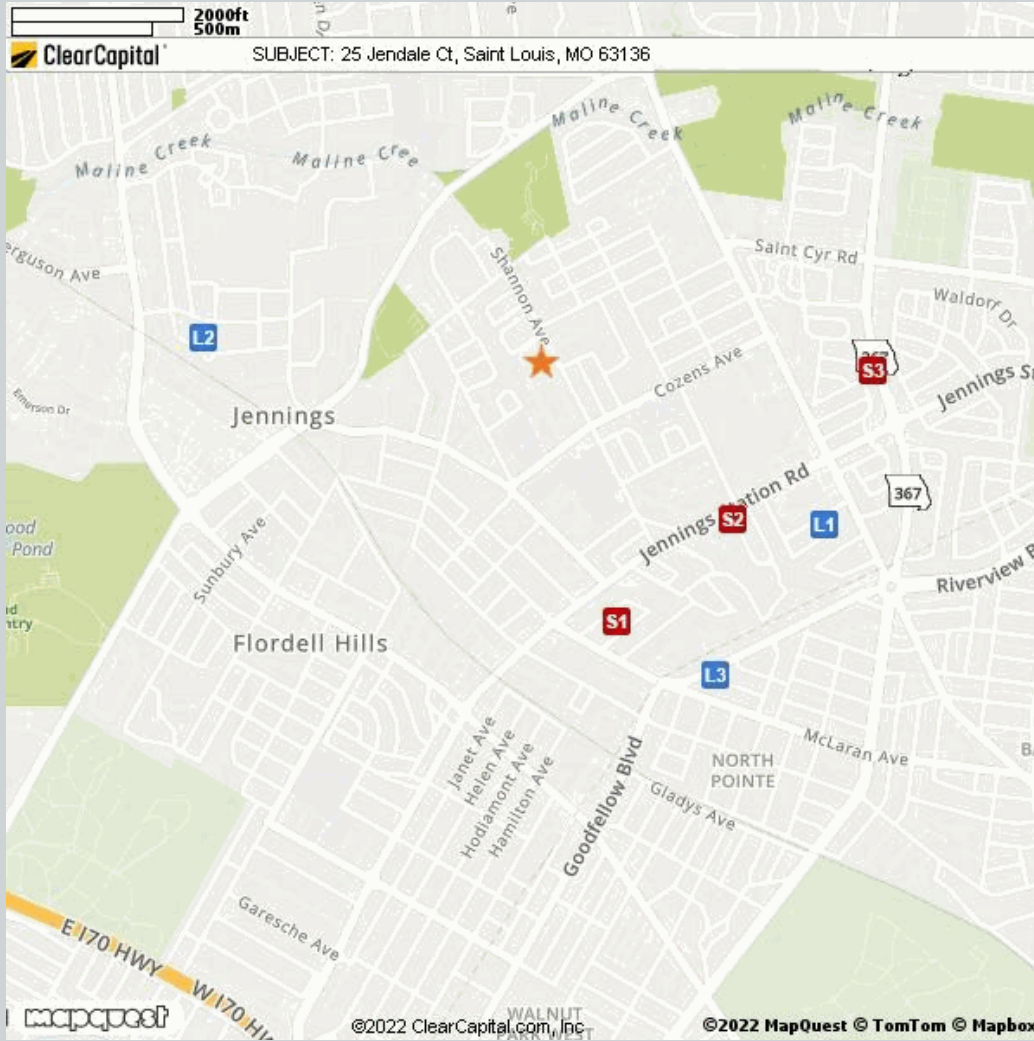
