<p>As per public record, Subject is sold for \$480,000 on 03/30/2022. But no MLS was available for the transaction. To locate comparable it was necessary to exceed bed/bath count, garage, lot size, and condition in the report. Close date exceeds over 3 months for sold comps. The MLS search criteria looked for comparable with a GLA range of 1514 to 2272 Sq.Ft. and within a radius of 1.5 miles from the subject. In order to bracket the subject's GLA and condition, a search for comps was broadened to exceed proximity up to 1.5 miles. The subject is located near the worship place, school, park, busy road, commercial. All comparable have similar location factors and support subject value and marketability. In delivering final valuation, the most weight has been placed on CS2 and LC2, as they are most similar to subject condition, and overall structure. Subject attributes are from Tax record.</p>

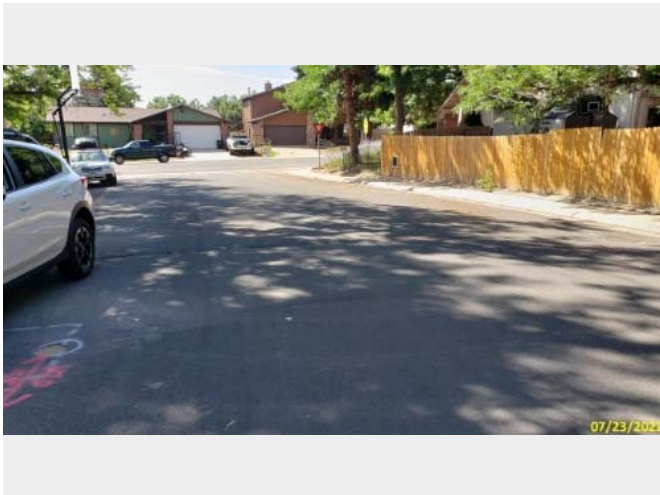

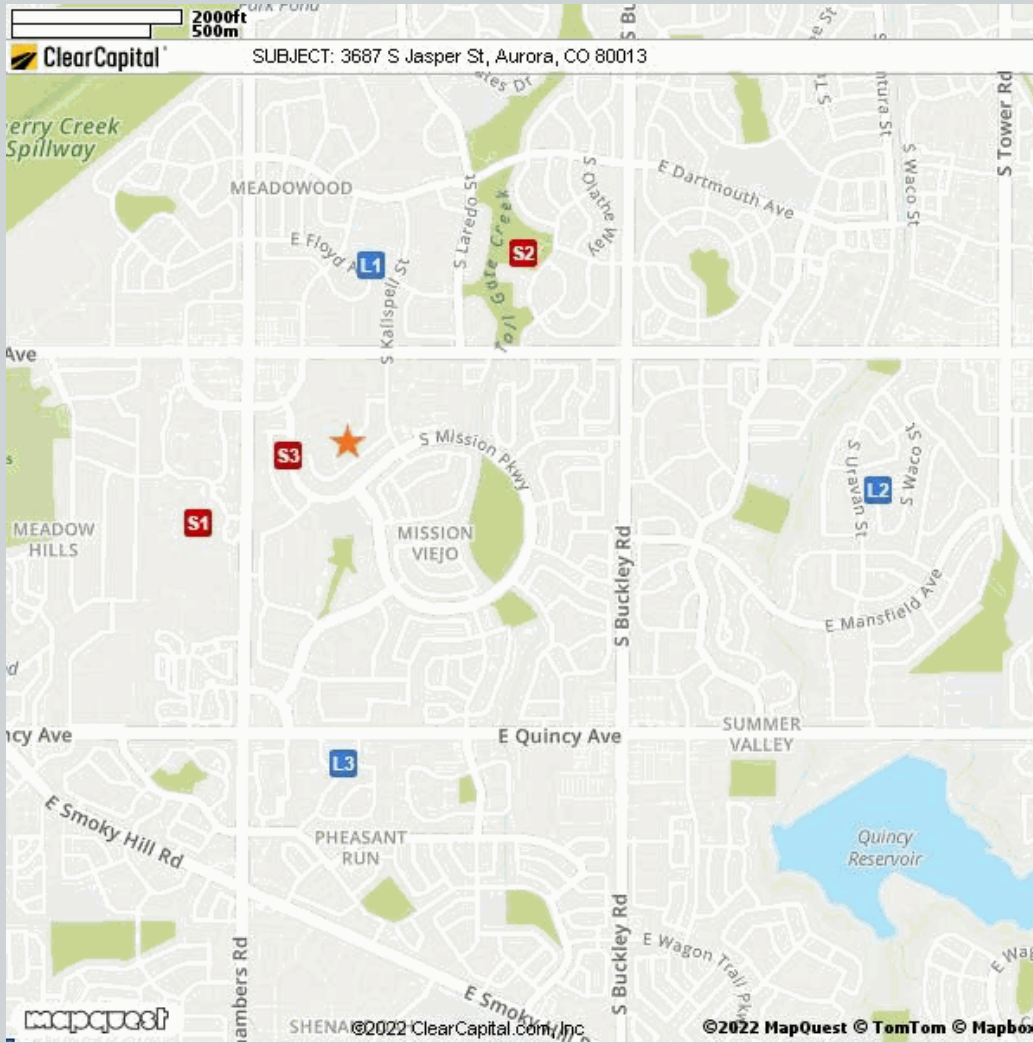
