Subject property is noted to be in average condition from the exterior and is located in a residential area of similar homes with no adverse external influences noticed. I went back 12 months, out in distance 2 miles, and even with relaxing gla search criteria I was unable to find any comps which fit the requirements. Within 2 miles and back 12 months I found 10 comps of which I could only use 3 due to lot size factors. The ones used are the best possible currently available comps within 2 miles and the adjustments are sufficient for this area to account for the differences in the subject and comps</p>

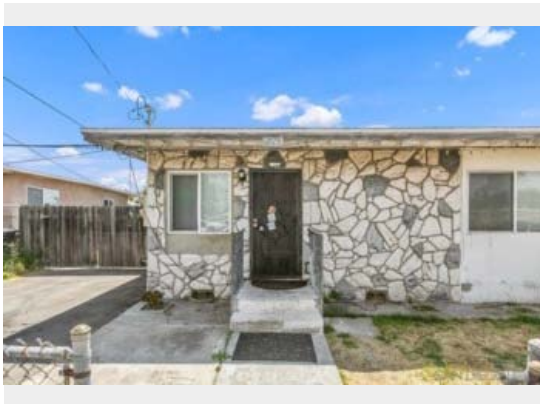
