Comments Regarding Pricing Strategy

Comparison analysis was done by collecting market data, selecting the most appropriate comparable properties, verifying market data, applying appropriate adjustments, and reconciling the various adjusted indicators of value into a value estimate. Market prices are increasing. Low-interest rates, low inventory, and increased demand are driving prices upward. The average marketing time is 60 days. All comps were the closest possible to the subject in lot size, sq ft., and age, no better sale and active comps were found; therefore I include comps over 1 mile far from the subject property with inferior and superior features. I went back 11 months, out in distance 1miles, GLA 20%-30% variance, age 30 years variance, lot size within 0.10-0.50 acre. The comps used are the best possible currently available comps within 1-mile and the adjustments are sufficient for this area to account for the differences in the subject and comparables. The estimated adjustments for the comparables noted are as follows; GLA \$60 per square feet variance (if reached more than 100 sqft variance), age \$6000 every 10-year variance, bed \$6000 per bed count, half bath \$4000, pool variance \$30000, and garage \$6000 per garage space. The subject has unique attributes and there are no other sold and listing comps similar to the subject property's characteristics and sale date within 6 months that are within the immediate market area. The criteria and search area was expanded and all necessary adjustments have been made. Due to unavailable comps within the subject market's area, it is necessary to expand my search criteria and proximity. The comps used are the best possible currently available comps and the adjustments are sufficient for this area to account for the differences in the subject and comparables. The GLA varies slightly from the comps. This does not have an effect on the value as this is due to limited comps in that area. The subject remains strongly bracketed by these comps and results in an accurate evaluation. Market prices are stabilizing after a prolonged increase in value. Rising interest rates are pricing many buyers out of the market. Average marketing time is 30 days and trending upwards.




