<p>Subject was recently sold on 04/05/2022 for \$350000 on public record. No mls available. The subject is in a neighborhood with commercial activity and public support facilities which are beneficial to the community. All necessary amenities and public transportation are located within close proximity to the subject. Neighborhood appears to be in average condition when compared to other similar communities in the area. All necessary amenities and public transportation are located within close proximity to the subject. There were no functional or economic obsolescence observed. I have searched a distance up to 0.5 mile GLA +/-20% similar lot size up to 6 months back. It was necessary to use comparable with variance in bed/bath count. It was necessary to exceed the lot size variance guideline of 25% in an effort to use the best available Comparable from within the subject's market area. Based on exterior observation, subject property appears to be in average condition. As long as the subject is priced within the most recent values of the subject's comps there should not be a problem with resale. In delivering final valuation, most weight has been placed on CS1 and LC3 as they are most similar to subject condition and overall structure. Due to limited comparable from same location, it was necessary to use comparable from across the busy street but from similar neighborhood. Subject is located near busy street, commercials and water bodies. However, it will not impact subject's marketability. Subject details are taken from tax record.</p>

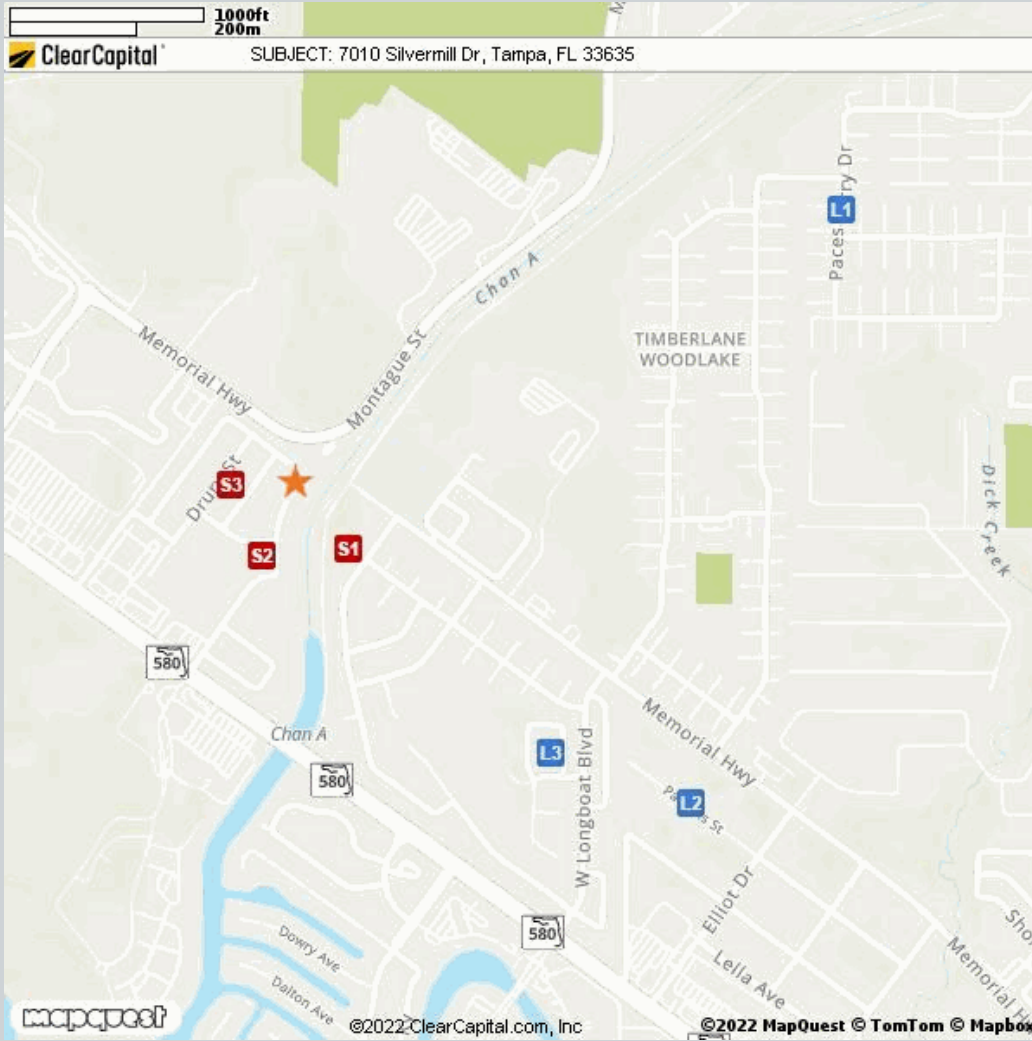
