Reasons for Adjustments Why the comparable sale is superior or inferior to the subject.

- Sold 1** It is inferior because of having a smaller GLA. Overall, similar in design and appeal and has comparable views. Adjustments: \$3495 due to sq ft, -\$517 due to the lot, -\$400 due to age, \$4500 due to room count.
- Sold 2** Shows the best support from my value conclusion. Overall, it has the most comparable characteristics and most importantly the most similar location/view which is one of the biggest factors with the subject. Adjustments: \$1005 due to sq ft, -\$2020 due to the lot, \$1000 due to age, \$6000 due to room count, -\$5,000 due to updates.
- Sold 3** It also has the same view as the subject, but its larger GLA, and updates, and having a larger lot makes this superior to the subject. Therefore my value conclusion most aligns with Sale 2. Adjustments: -\$1095 due to sq ft, -\$2443 due to the lot, -\$3200 due to age, \$6000 due to room count, -\$30,000 due to updates.

Sales: MLS #35670899/242 Kirkaldy The lack of available comps in the immediate neighborhood of the subject made it necessary to expand the search to use comps with larger lots. Chronological age and site-size differences do not have a significant effect on value. Upon review of all the pertinent information, an opinion of the as-is market value of \$225,000 is adequately supported with emphasis placed on List No. 2 and Sale No. 2. Based on an exterior inspection, from the street, the subject property has no observable adverse condition noted that would cause a safety or health risk/concern at the time of inspection. Therefore no resale issues are foreseen.</p>

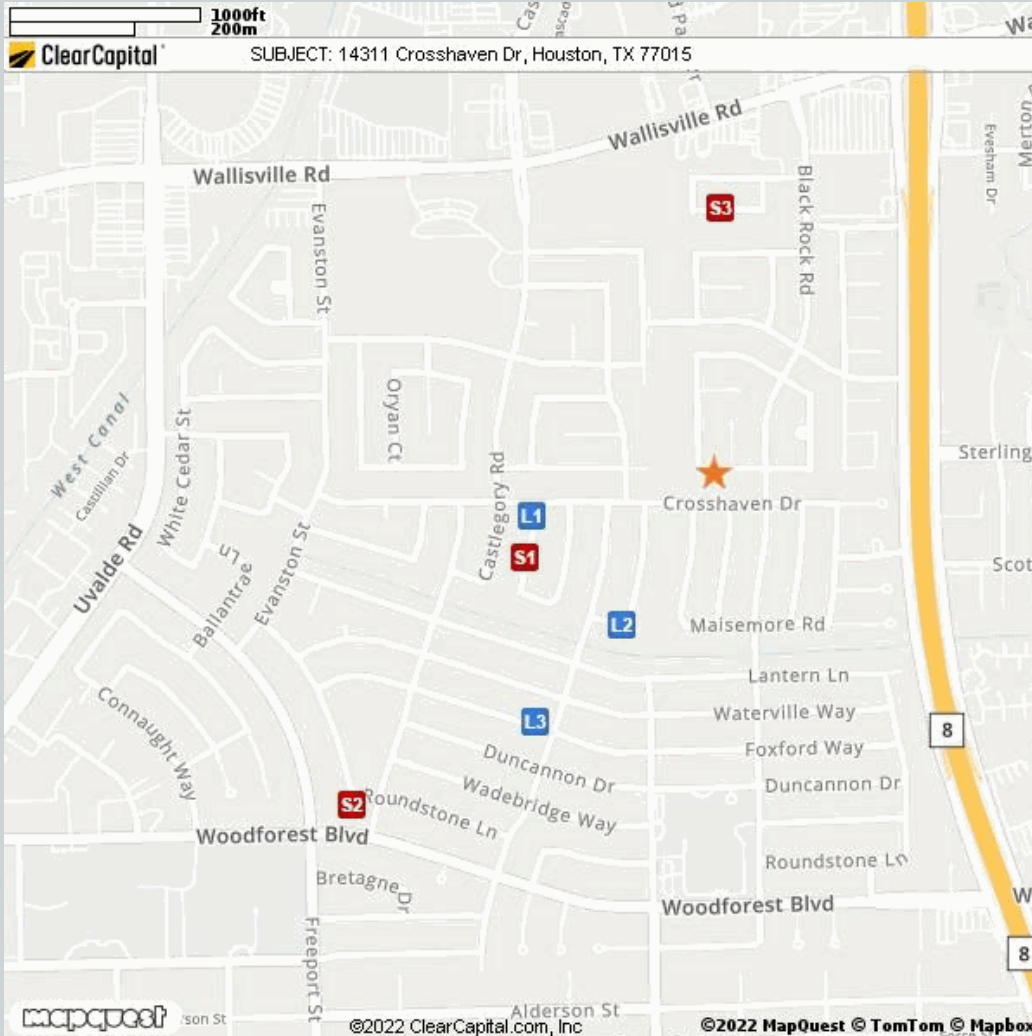
