<p>Subject is sold in public record for \$ 239,000 on 5/9/2022, no MLS available. I went back 12 months, out in distance 1 mile, and even with relaxing +/-20 year built, +/-20% GLA search criteria I was unable to find any comparable which fit the subject requirements. Due to limited comparable it was necessary to exceed the proximity up to 1.40 miles, style, closed date beyond 3 months, year built 30%, 30 % GLA, condition, bed/bath count and lot size. Comparable (S2) received multiple offers and sold for higher value than the list price. Subject is located closer to commercial, school, railway track and highway. This however, will not have effect on value and marketability. In delivering final valuation, most weight has been placed on CS2 and LC2, as they are most similar to subject condition and overall structure. Subject attributes are from Tax record.</p>

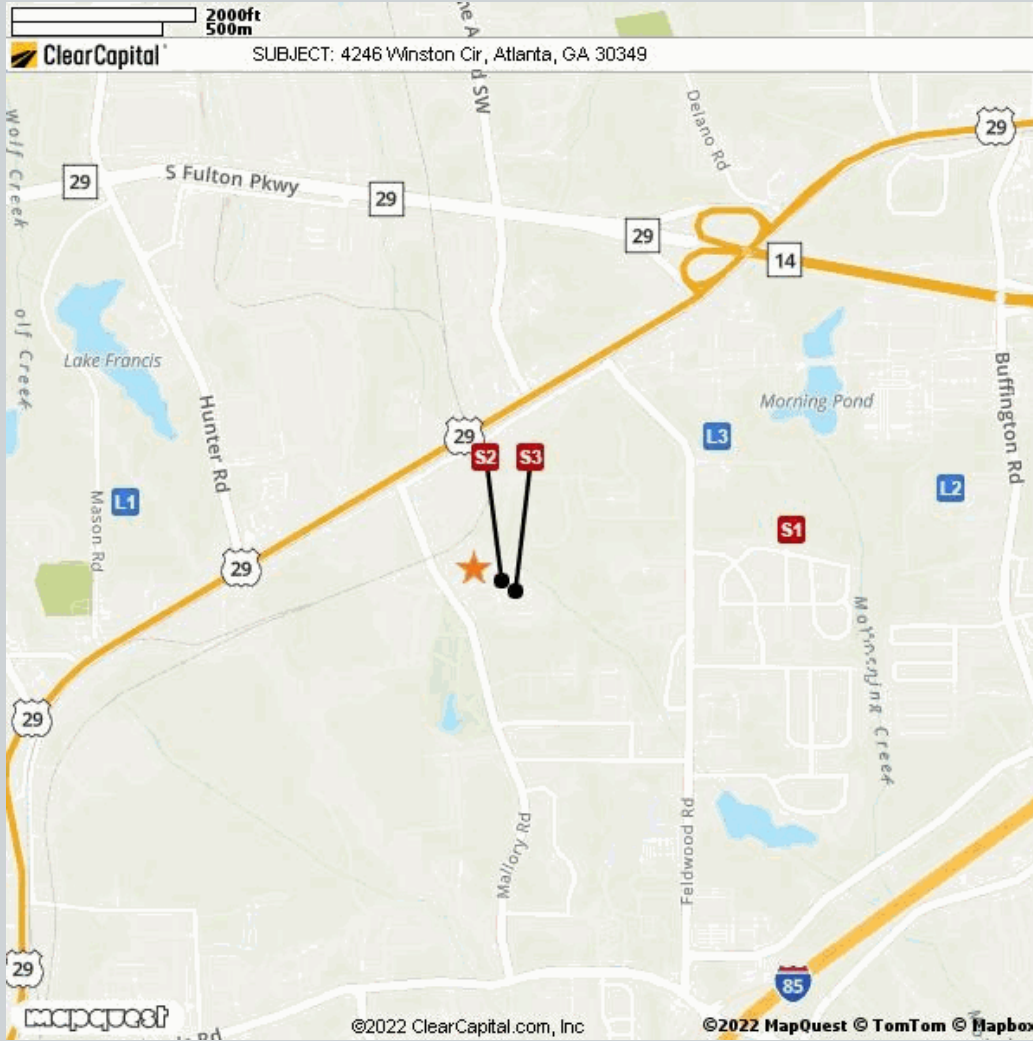
