The comps below were considered but because they reflected a value very different than the rest of my comps, they were replaced with comps that better supported the market and my final value conclusion. Listings: MLS #7130481/17327 Comorant Ct, Sales: MLS #87493010/17326 Wigeon Way, Sales: MLS #57097859/17423 Wigeon Way, Sales: MLS #96180583/17435 Wigeon Way The lack of available comps in the immediate neighborhood of the subject made it necessary to expand the search to use comps with larger GLAs and smaller lots. Chronological age and site-size differences do not have a significant effect on value. The search was extended back 4 months, out in distance of 1 mile, and even with relaxing 35% GLA search criteria I was unable to find many comps that fit within 20% GLA requirements and had similar style and appeal. Within 1 mile and back 4 months, I found 10 comps of which I could only use 6 due to condition or site-size factors. The comps used are the best possible currently available comps within 1 mile and the adjustments are sufficient for this area to account for the differences in the subject and comps. Upon review of all the pertinent information, an opinion of the as-is market value of \$210,000 is adequately supported with emphasis placed on List No. 2 and Sale No. 2. Based upon an exterior inspection, from the street, the subject property has no observable adverse condition noted that would cause a safety or health risk/concern at the time of inspection. Therefore no resale issues are foreseen.






