As per MLS, subject appears to be recently renovated meaning the subject is in good condition. To locate comparables, it was necessary to exceed bed/bath count, GLA, garage, lot size in the report. Due to limited number of comparables, close dates exceeded over 3 months. The MLS search criteria looked for comparables with a GLA range of 917 to 1703 sq ft and within a radius of 1.3 miles from the subject. In order to bracket the subject's GLA and condition, a search for comparables was broadened to exceed proximity up to 1.3 miles. However, there is no change in subject value and marketability. In delivering final valuation, the most weight has been placed on CS2 and LC3, as they are most similar to subject condition and overall structure. Subject details are from tax records.






