- **Sold 2** Shows the best support for my value conclusion. Overall, it has the most comparable characteristics and, most importantly, the most similar location/view, which is one of the biggest factors with the subject. Adjustments: \$570 due to sq ft, -\$5354 due to the lot, and \$1500 due to room count.
- **Sold 3** It also has the same view as the subject, but its larger GLA, updates, and larger lot make this superior to the subject. Therefore my value conclusion most aligns with Sale 2. Chronological age and site-size differences do not have a significant effect on value. Upon review of all the pertinent information, an opinion of the as-is market value of \$330,000 is adequately supported with emphasis placed on List No. 2 and Sale No. 2. Based upon an exterior inspection from the street; the subject property has no observable adverse condition noted that would cause a safety or health risk/concern at the time of inspection. Therefore no resale issues are foreseen.




