Comments Regarding Pricing Strategy

The subject is recently pending for \$239900 on 11/06/2022. The subject is in average condition and no repairs were noted. As long as the subject is priced within the market value of the most recent similar comps within the subject property's area there should not be a problem with resale. Within 1 mile, 20% GLA +/-, Year built 20 +/-, there were limited comparables available in the subject neighborhood. Therefore it was necessary to exceed the closed date, style, condition, basement, garage, lot size and proximity exceeded up to 2.00 miles. Comparables(CS1, CS2) received multiple offers which resulted in an increased final sale price relative to the list price. Due to limited comps in the area, 3 sales with contract dates within 120 days of the effective date of the report could not be provided. In delivering the final valuation, most weight has been placed on CS2 and LC2 as they are most similar to the subject condition and overall structure. The subject property is located near the residential area, highway, school, park, worship, main roads, and other commercial. 




