<p>I went back 3 months, out in distance .50 miles, and was unable to find all 2 sold comps. I had to go out in distance 1-mile, similar neighborhoods with same market values, due to lack of sales in the neighborhood. Within 1 mile I found 3 active comps of which I could only use due to low or zero inventory factors. The comps used are the best possible currently available comps within 1 mile and the adjustments are sufficient for this area to account for the differences in the subject and comparables. Most sellers are receiving multiple initial offers over asking price due to low or zero inventory. There are more buyers that listings. The market isn't driven by REOs.</p>

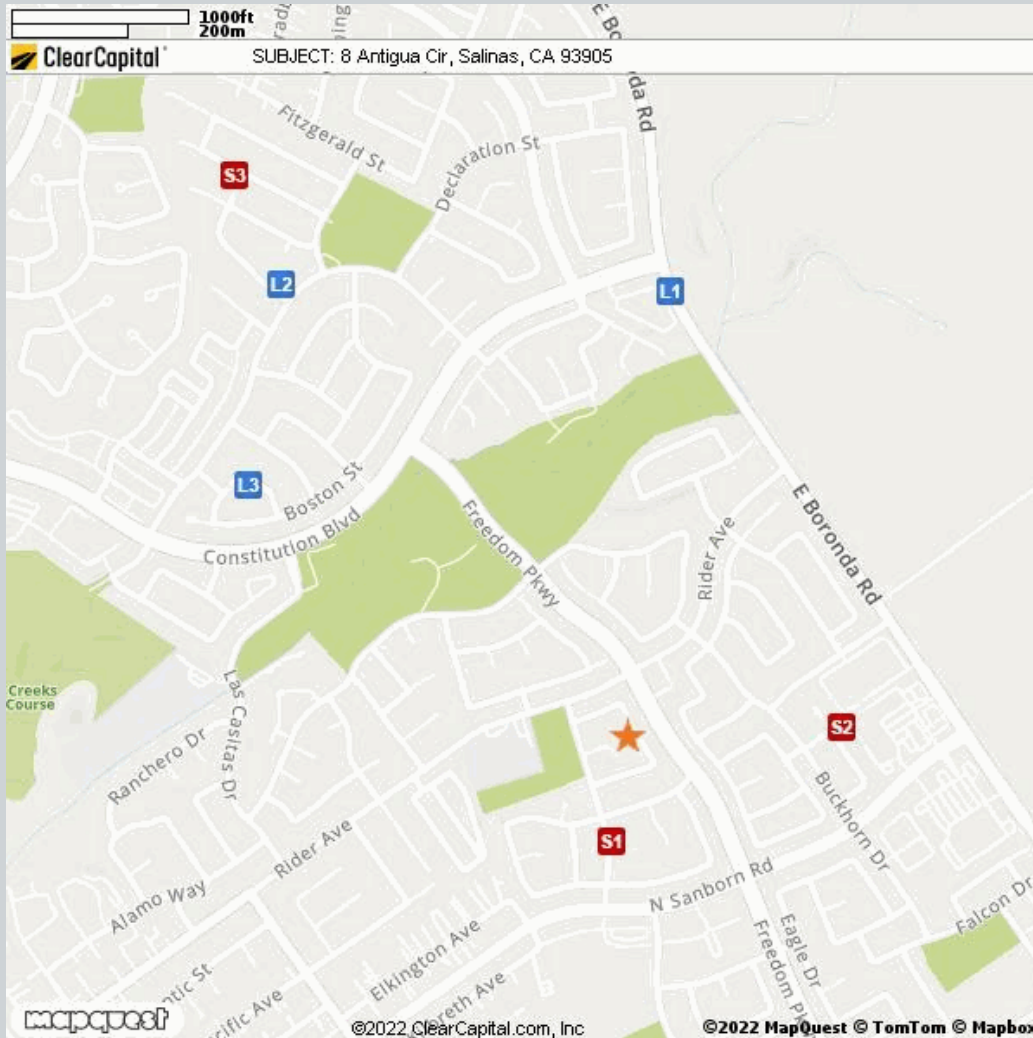
