Comments Regarding Pricing Strategy

As per public record, Subject is sold for \$360500 on 6/15/2022. But no MLS was available for the transaction. The subject is average condition and no repairs noted. As long as the subject is priced within the market value of the most recent similar comps within the subject property"s area there should not be a problem with resale. Within 1 mile, 20% GLA +/-, Year built 20 +/-, there were limited comparables available in the subject neighborhood. Therefore it was necessary to exceed the closed date, condition, year built, lot size and proximity exceeded up to 3.35 miles. Sales differ by more than 10 years in age but are still felt to be reliable Comparable. Due to limited comps available, active comps were despite not bracketing the GLA since they were considered to be reliable comparable. Due to lack of comparable it was necessary to use comparable with variance in bath count for active comps. Comparable(CS2) received multiple offers which resulted in an increased final sale price relative to list price. Due to limited comps in the area, 3 sales with contract dates within 120 days of the effective date of the report could not be provided. 




