#### **Comments Regarding Pricing Strategy**

Up to 1 miles there were no list comparables without pool. So I have used the best comps available. The subject is a 3 bed/2 bath with 2954 Sq. Ft SFR property. In an effort to better bracket the feature set of the subject it was necessary to exceed the year built, bed/bath count and lot size guideline. Due to limited comps in the area, list comp were used despite not bracketing the lot size as they are still considered to be reliable comparable. Due to limited comps in the area, 2 sales with contract dates within 120 days of the effective date of the report could not be provided. The value and marketability will not be affected with the subject being located near highway, park, main road, water bodies and commercial area. To reach a value conclusion, most weight was placed on CS1 and LC1, as they are most similar to subject condition and overall structure.


