<p>The subject is an SFR home in average condition. Based on the exterior observation the subject appears to be in average condition and has no negative features. As long as the subject is priced within the market value of the most recent similar comps within the subject property's area there should not be a problem with resale. Within 1 mile, 20% GLA +/-, Year built 20 +/-, there were limited comparable available in the subject neighborhood. Therefore it was necessary to exceed the closed date, condition, style, pool, lot size. The comparable selected were considered to be the best available. In delivering final valuation, most weight has been placed on CS1 and LC1 as they are most similar to subject condition and overall structure. Subject is located near residential, commercial, major roadways, waterbodies and it won't affect the market value. The details were taken as per the tax record. Comparable(CS1,CS2,CS3) received multiple offers which resulted in an increased final sale price relative to list price.</p>

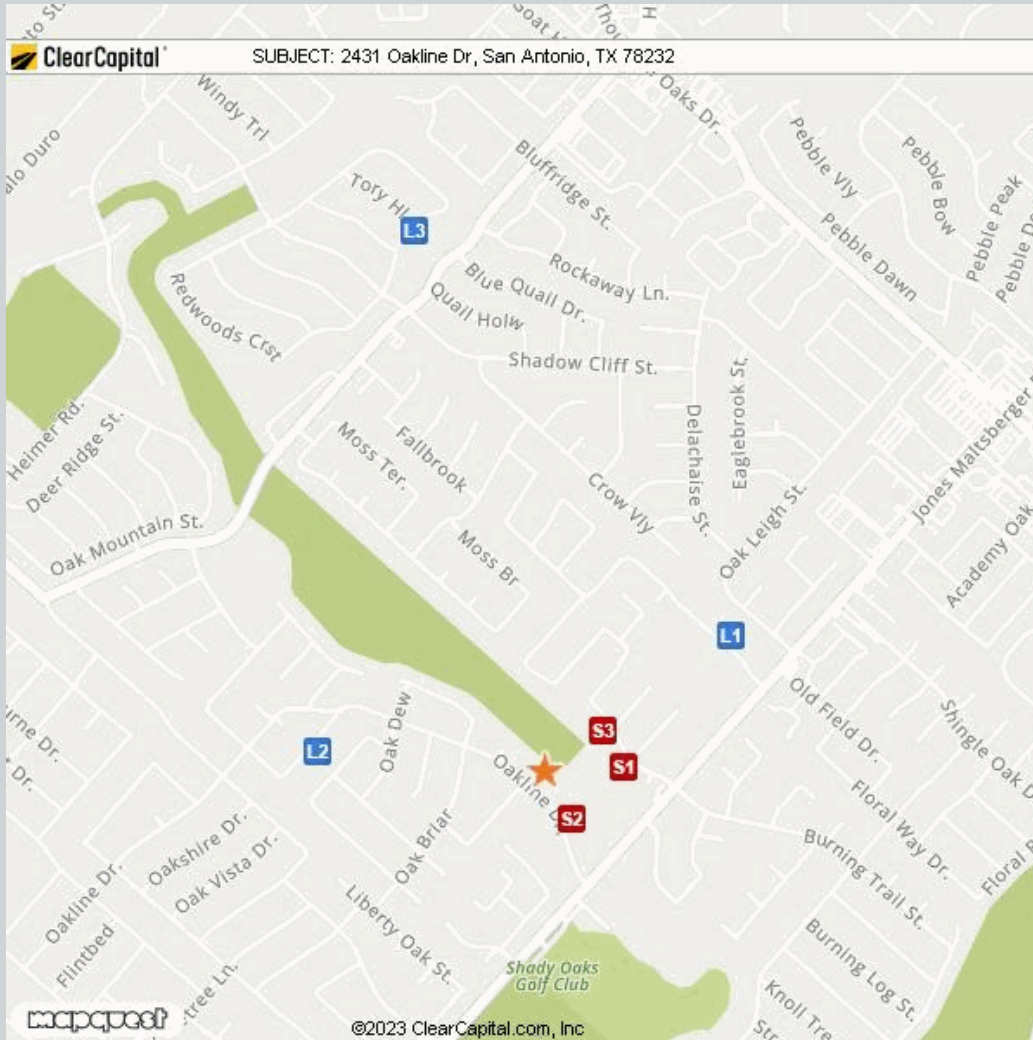
