The value for the subject was weighted the most towards these two comps for that reason. Sale 3 has similar condition and similar GLA and Listing 3 has similar view and condition.</p>

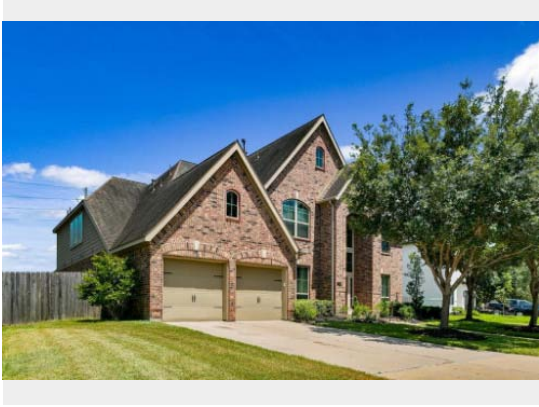

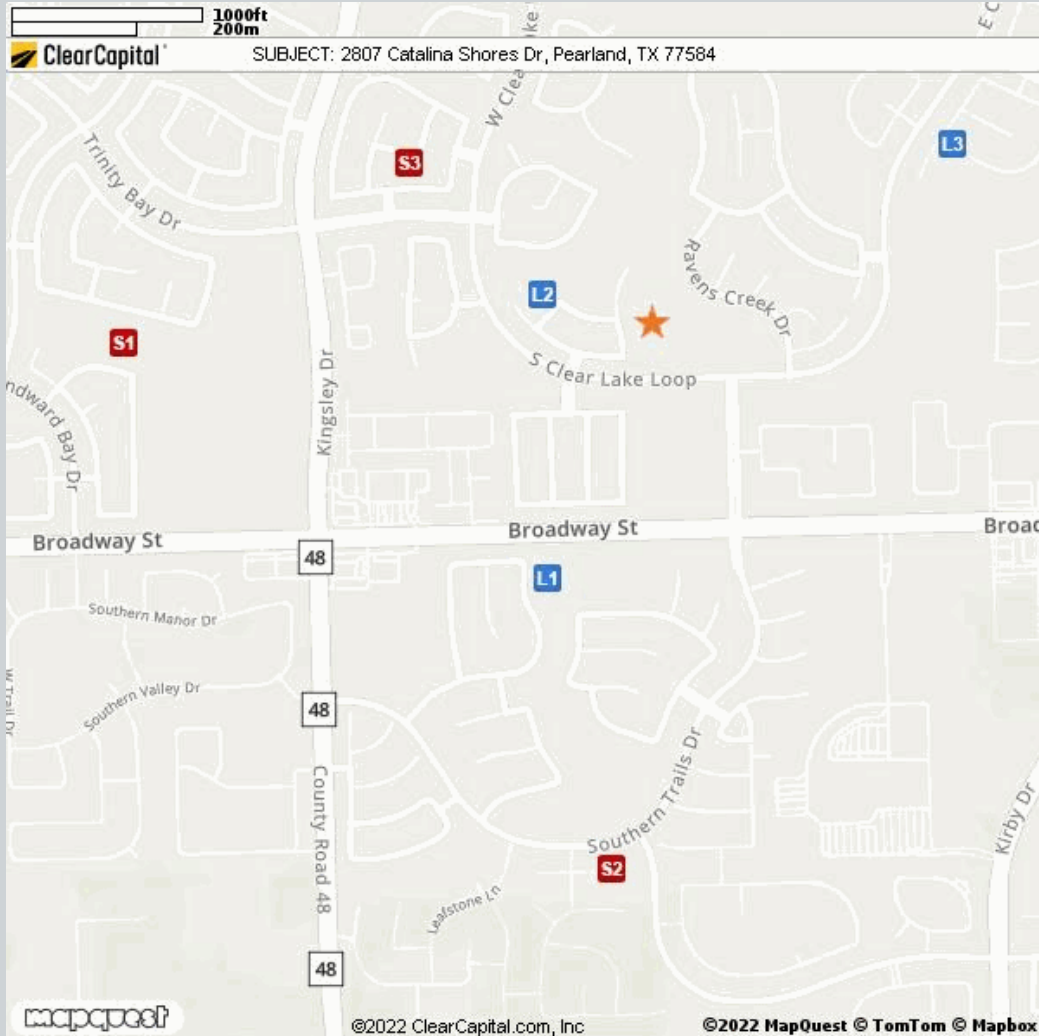
