- Sold 2** Adjusted -4400 for GLA. General property maintenance is consistent with the neighborhood with average to normal wear and tear. Traffic and noise from traffic is minimal.
- Sold 3** +6950 for GLA. General property maintenance is superior with the neighborhood with average to better wear and tear. Traffic and noise from traffic is less and quieter.

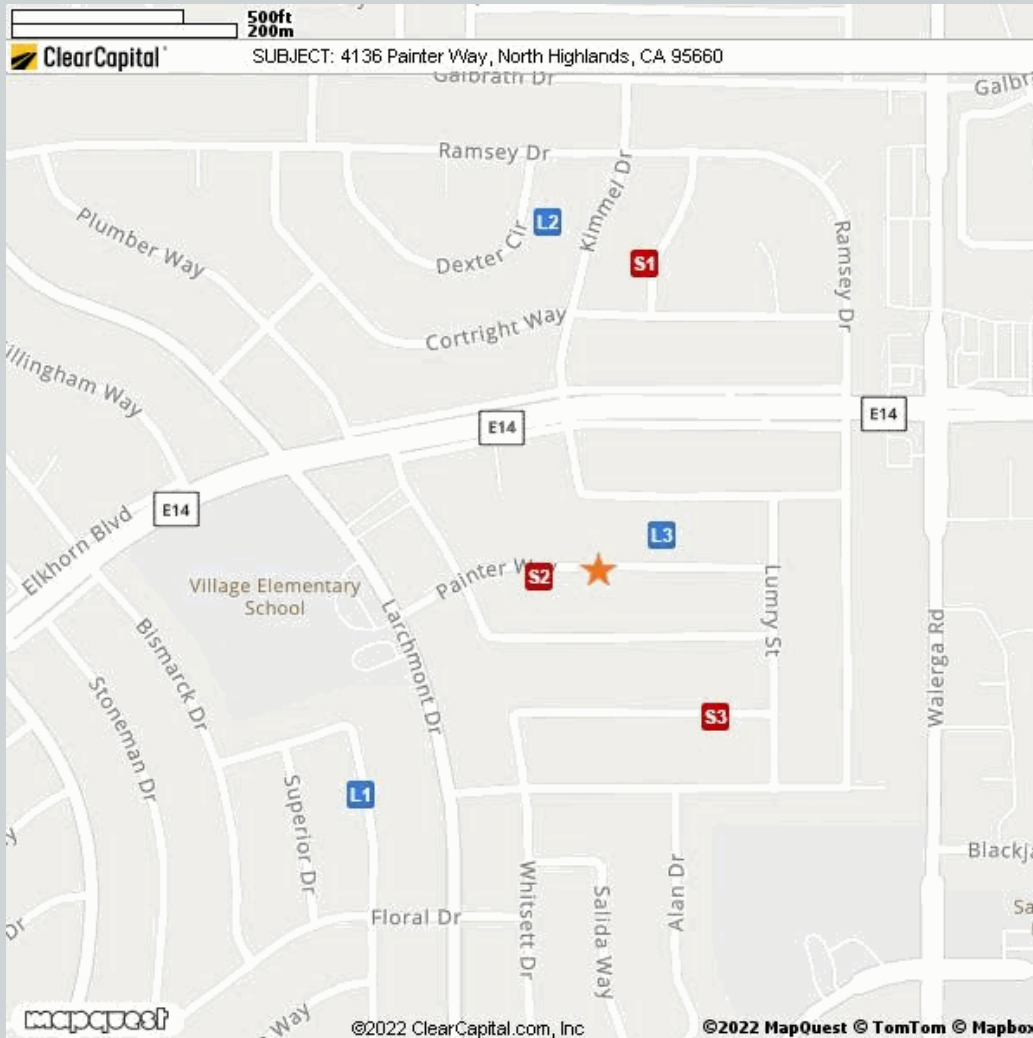
