<p>To locate comps, it was necessary to exceed proximity upto 3.71 miles, bed/bath count, lot size guidelines. Subject bed/bath count is unique for the neighborhood. Due to limited comps in the area, comps were used despite not bracketing the bed/bath count as they are still considered to be reliable comparables. In order to stay within 3.71 miles, it was necessary to use comparable in wider price range. Subject is located near major roads, school, commercial and water bodies. This however will have no impact on value. In delivering final valuation, most weight has been placed on CS1 and LC1 as they are most similar to subject condition and overall structure.</p>

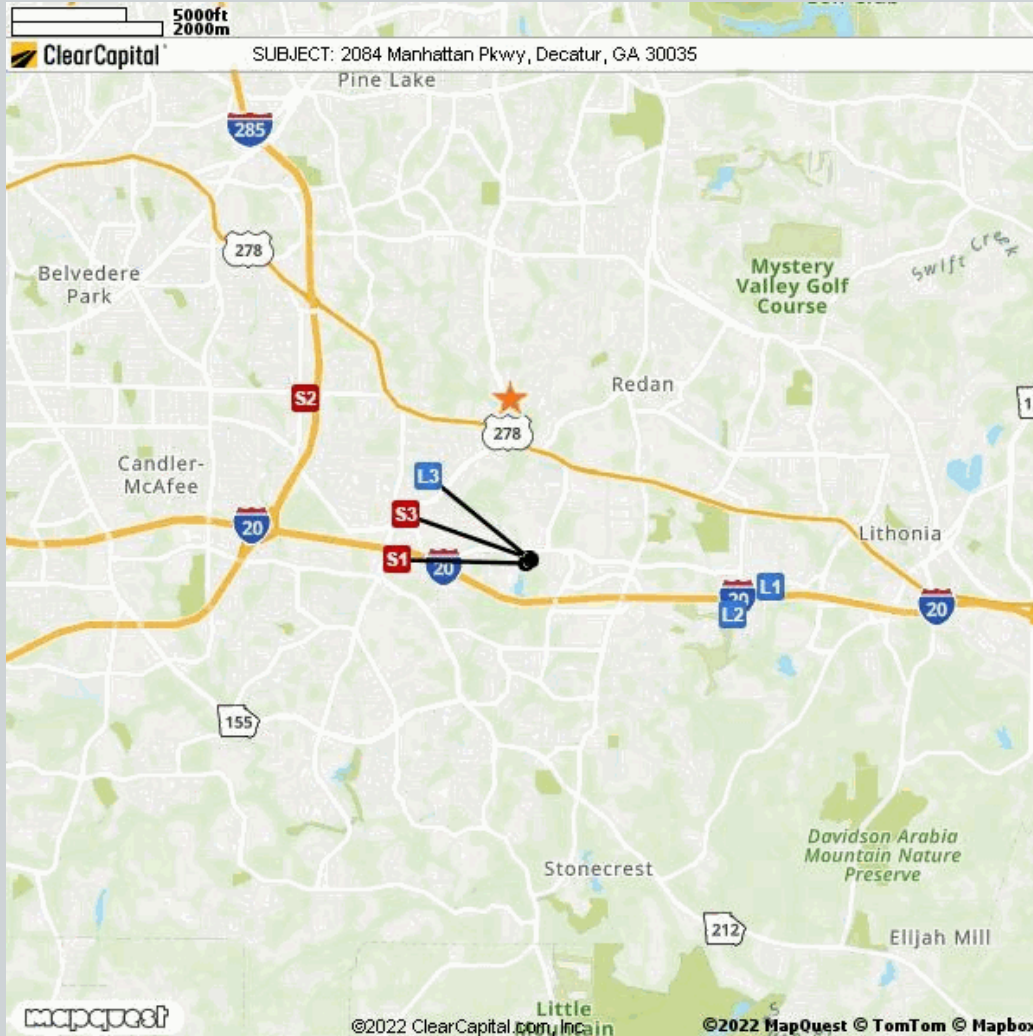
