Subject is in the vicinity of water but this doesn't have any effect on subject's marketability. Subject is in the vicinity of a busy road and commercial properties. This could have a negative effect on subject's marketability. There has been no Sold activity in subject's immediate neighborhood since Aug. of last year. ClearProp indicates a 12% market increase in the last 6 months but due to a lack of inventory, there isn't comparable sold data to support this. I was forced to use CS1 in order to support a proper market increase. I gave most weight to CL2 and CS2 which is similar to subject in overall appeal and condition. The Anticipated Sales Value (ASV) given should allow subject to get under contract within 90 days. Final value conclusion given is based on Fair market value. It was necessary to expand beyond DATED COMPS, DISTANCE and CONDITION guidelines due to limited comps in subject's immediate neighborhood. 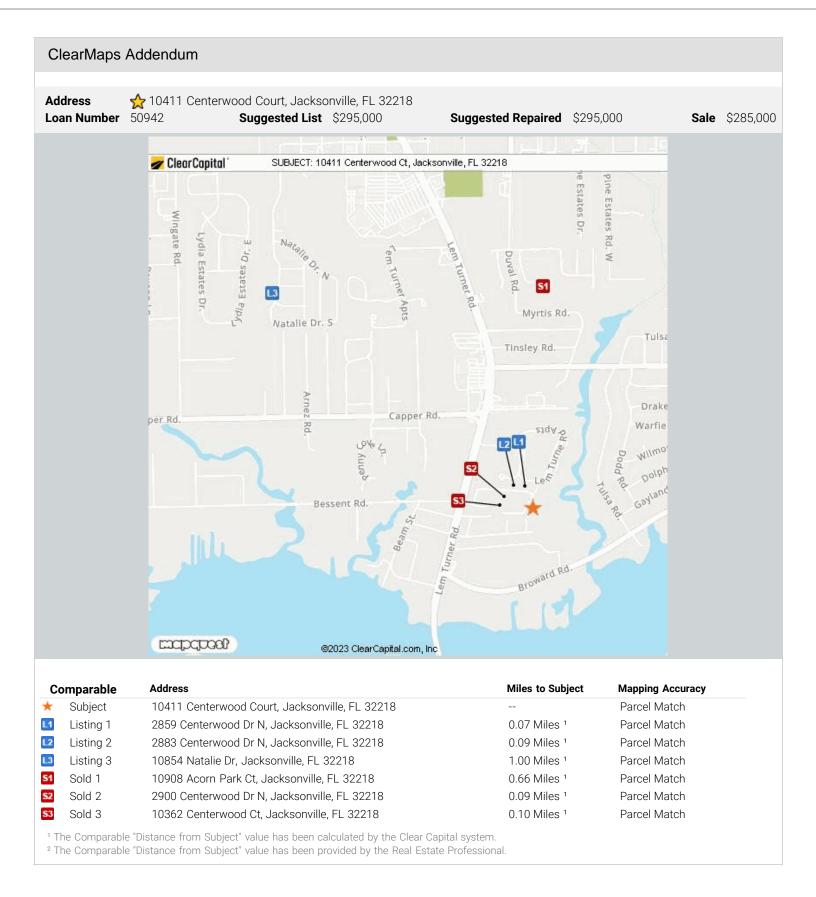
