<p>Subject is a SFR property. Subject is currently active for \$375000. Subject bed/bath count is unique in its neighbourhood. Subject has 2 bed/2 bath. The average home in the area has 3 to 4 bedrooms. This means the average home in the area is slightly superior to the subject in regards to this attribute. As there were limited active comps, it was necessary to expand GLA upto +/-30%.Due to limited comps in the area, active comps were used despite not bracketing the GLA as they are still considered to be reliable comparables.The lot size variance guideline was exceeded in an effort to use the best available comparable from within the subject's market area. It was necessary to use comparable with superior condition due to limited market activity in the subject's area. Subject is located near highway, major roads, park, school and commercial buildings. Due to limited comparables in the same side of the subject, some comparables were taken crossing the highway. However, this will not affect the subject value and marketability. In delivering final valuation, the most weight has been placed on CS2 and LC2, as they are most similar to subject condition, and overall structure. Subject details are from tax record.</p>

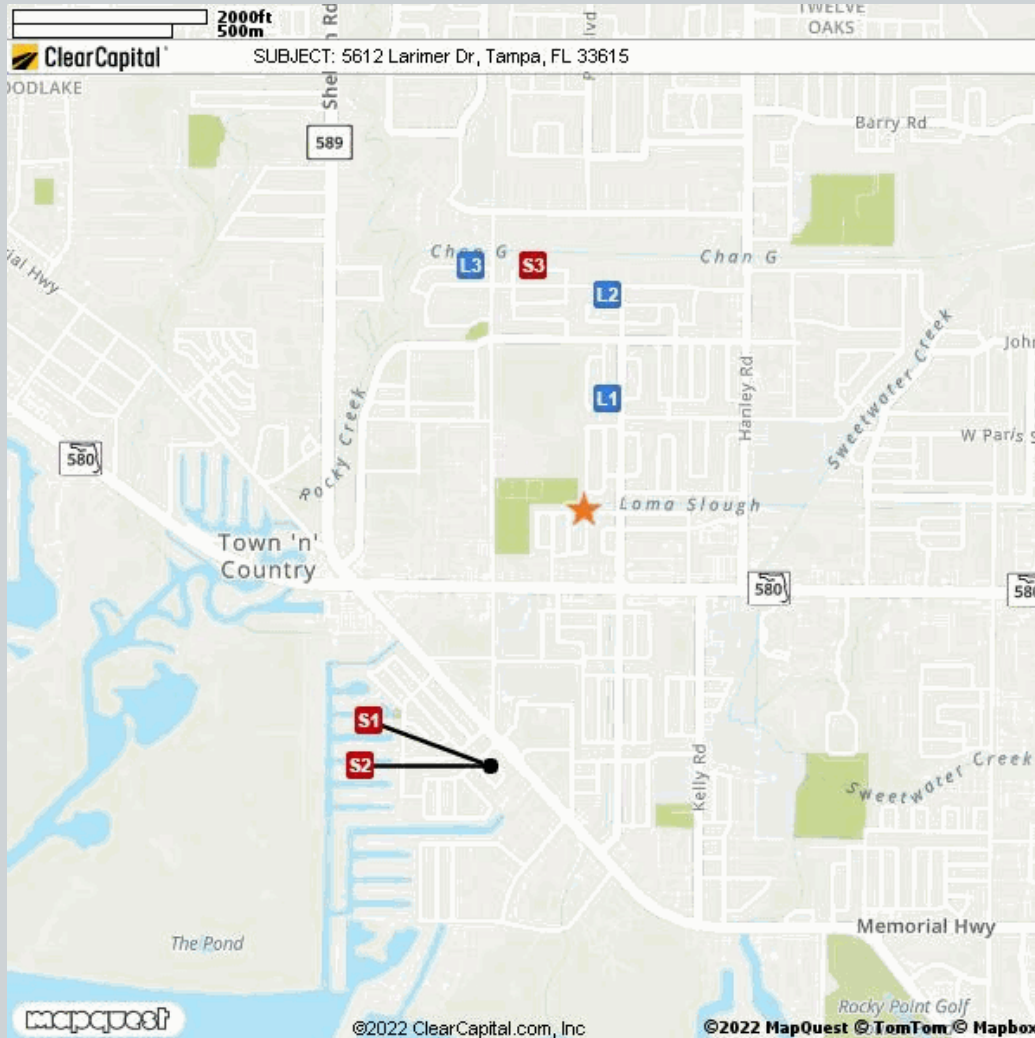
