Reasons for Adjustments Why the comparable sale is superior or inferior to the subject.

- Sold 1** It is inferior because of having a smaller GLA and for being an older building. Overall, similar in design and appeal and has comparable views. Also farthest in proximity to the subject compared to other comps used. Adjustments: \$4290 due to sq ft, -\$419 due to the lot, -\$1200 due to age, \$2500 due to 2-car garage, -\$7500 due to updates.
- Sold 2** Shows the best support from my value conclusion. Overall, it has the most comparable characteristics and most importantly the most similar location/view which is one of the biggest factors with the subject. Adjustments: -\$5820 due to sq ft, -\$107 due to the lot, -\$400 due to age, \$2500 due to 2-car garage.
- Sold 3** It also has the same view as the subject, but its larger GLA, needing TLC, and having a larger lot makes this superior to the subject. Therefore my value conclusion most aligns with Sale 2. Adjustments: -\$945 due to sq ft, -\$539 due to the lot, -\$1200 due to age, \$3000 due to room count, \$2500 due to 2-car garage, \$12,500 due to TLC, -\$8000 due to pool and spa.

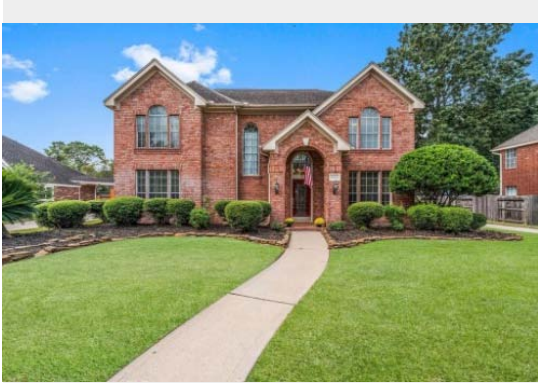

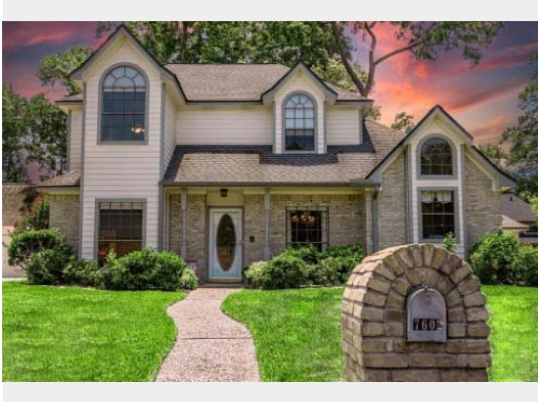

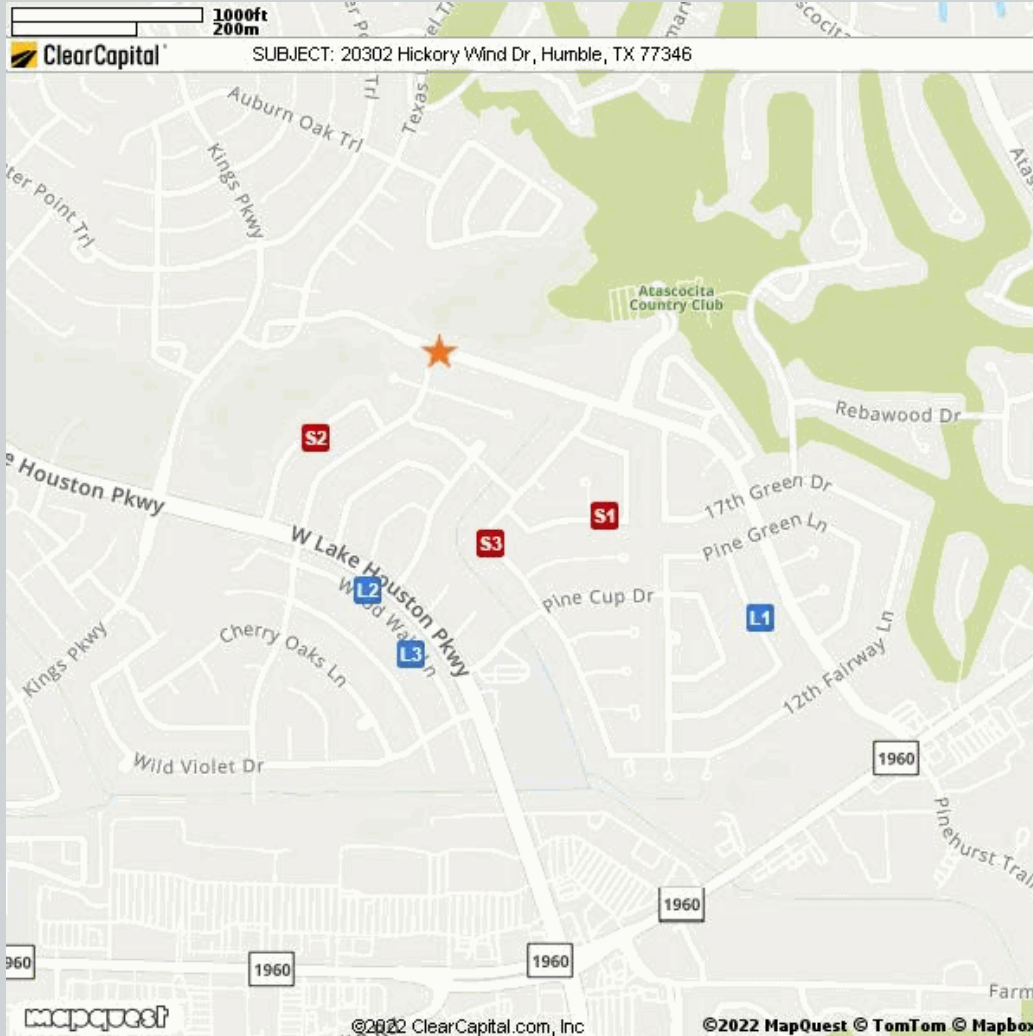
