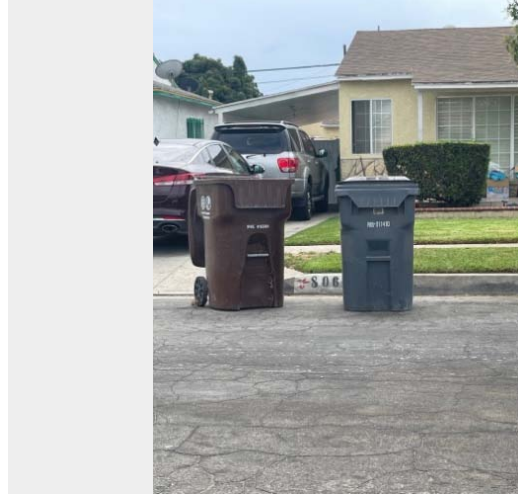
## Clear Capital Quality Assurance Comments Addendum
