- Sold 1** Adjusted -500 for acreage. Somewhat greater flow of traffic is present and with it there is more noise from traffic. Wear and tear seems to appear more apparent to the property with some maintenance advised
- Sold 2** Adjusted -1000 for acreage. General property maintenance is consistent with the neighborhood with average to normal wear and tear. Traffic and noise from traffic is minimal.
- Sold 3** Adjusted -500 for acreage. General property maintenance is superior with the neighborhood with average to better wear and tear. Traffic and noise from traffic is less and quieter.

I have yet been able to find from a public records or an MLS search a listing describing a property as average condition or average features. 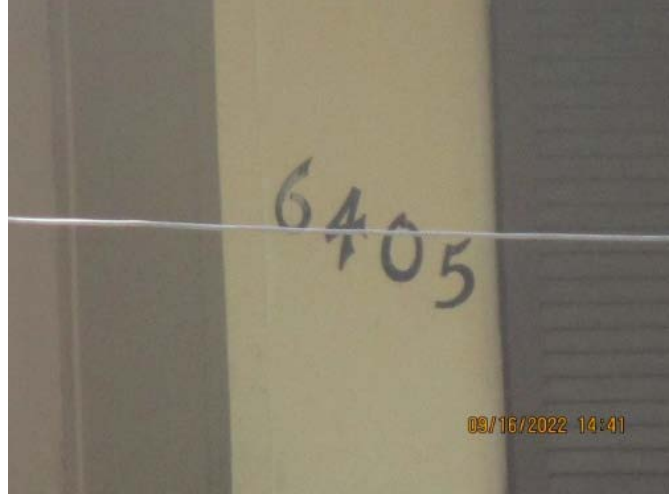
Clear Capital Quality Assurance Comments Addendum

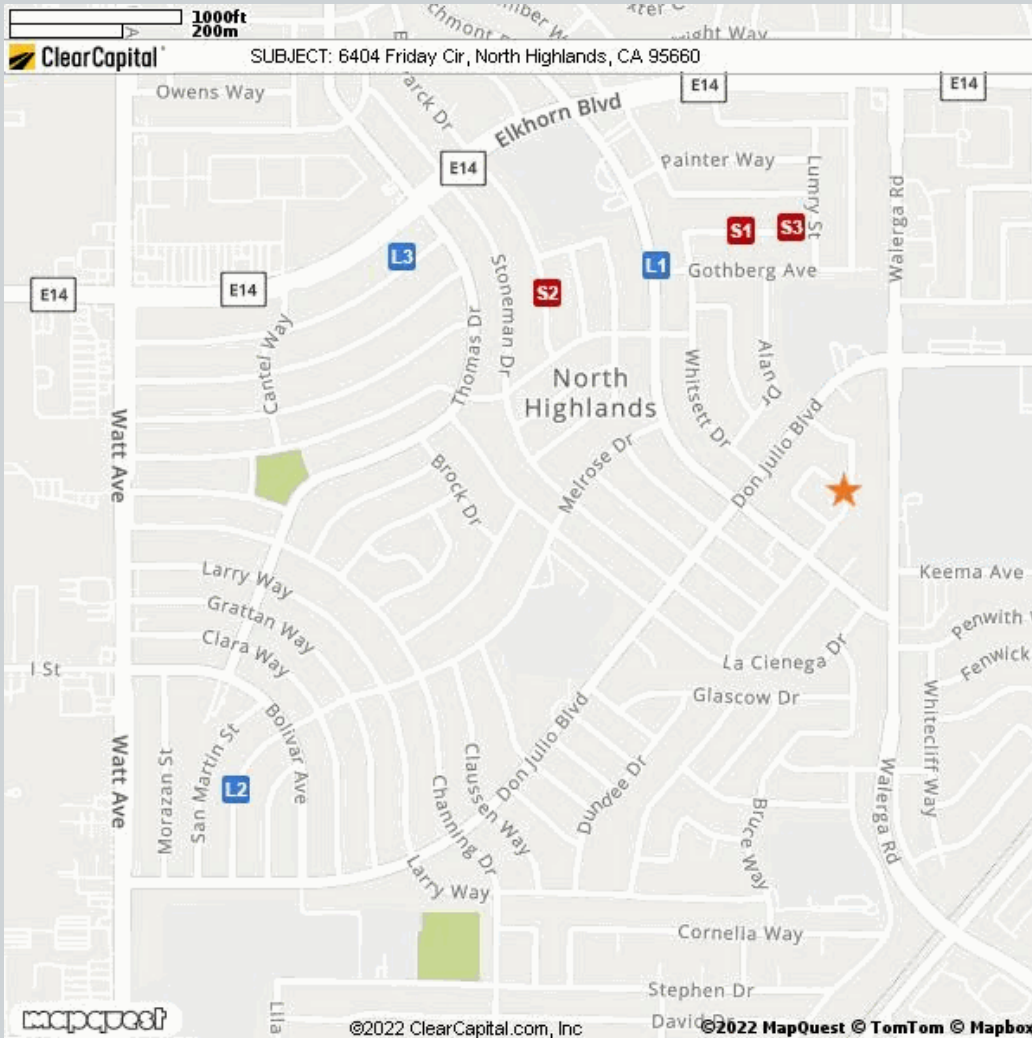
