However, there is a shortage of similar comps, especially properties in average condition, and therefore it was necessary to use oje superior condition comp within this report. Similar comps within the subject's market area support a Sale Price for the subject which is higher than the subject's recent Sales Price.</p>

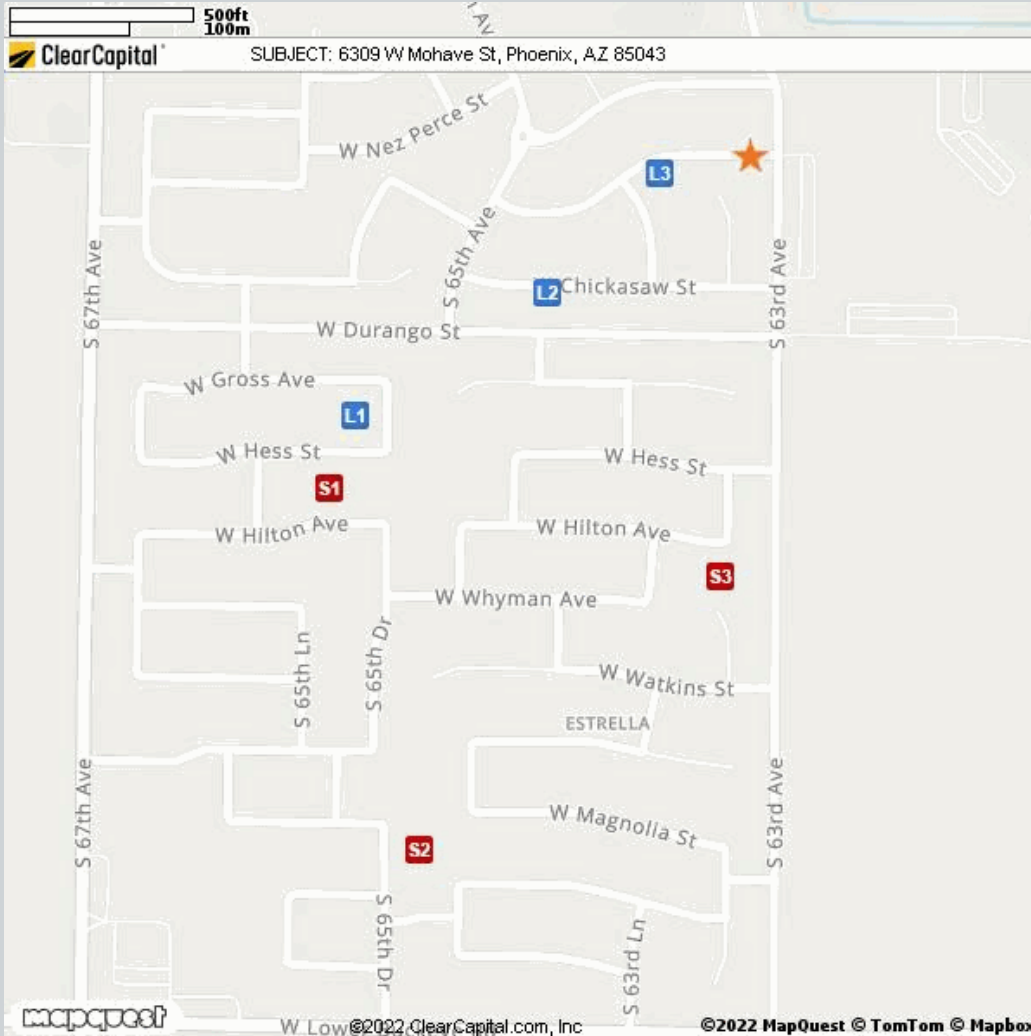
