There is a shortage of similar comps, especially properties in average condition, and it was necessary to use three superior condition comps within this report. 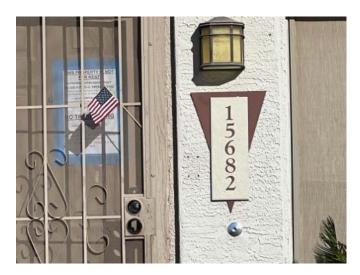

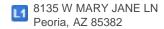

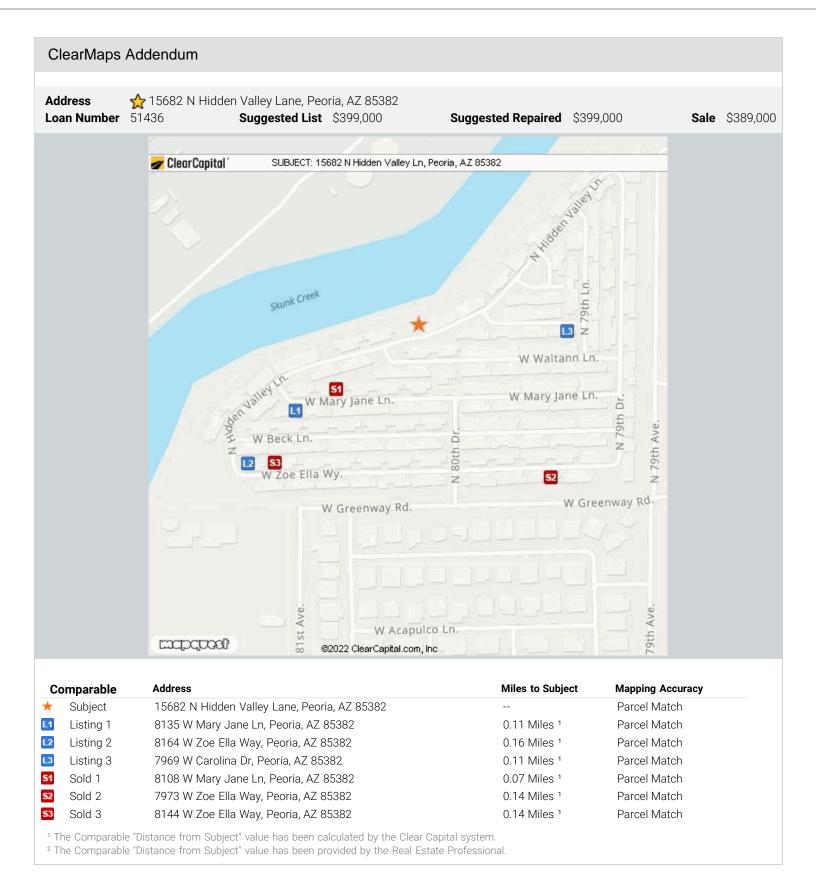
