<p>The subject is located near to highway and commercially active region, this will not have any impact on subject marketability as similar location comparable were used in this report. Within 1 mile, there were limited comparable available supporting subject market conditions. Hence I was forced to use comparable exceeding in sold date, condition, GLA, bed/bath count, lot size and proximity up to 1.7 miles. In delivering final valuation more weightage is been placed on CS2 and CL2 were selected as the best available comparable as they are most similar to subject condition and overall structure. As there were limited comparable available, I was unable to bracket lot size in active comparable. Comparable (s1, s2) received multiple offers which resulted in an increased final sale price relative to list price.</p>

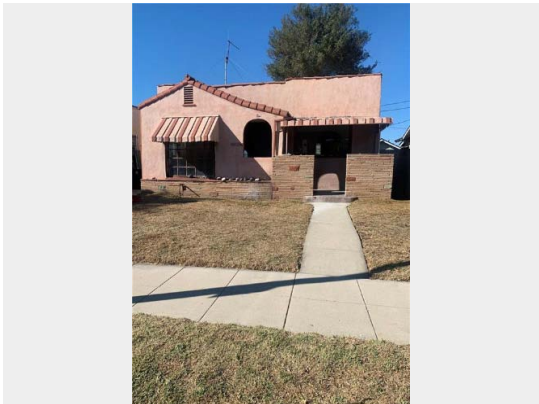

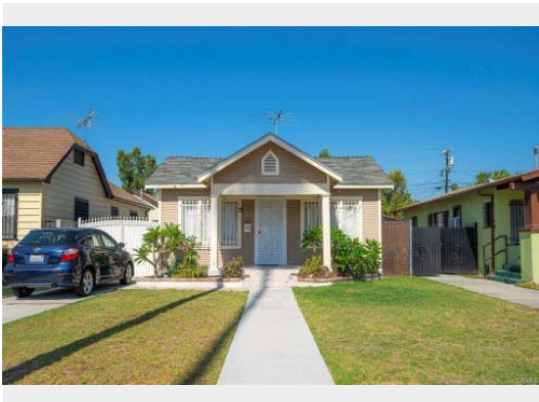

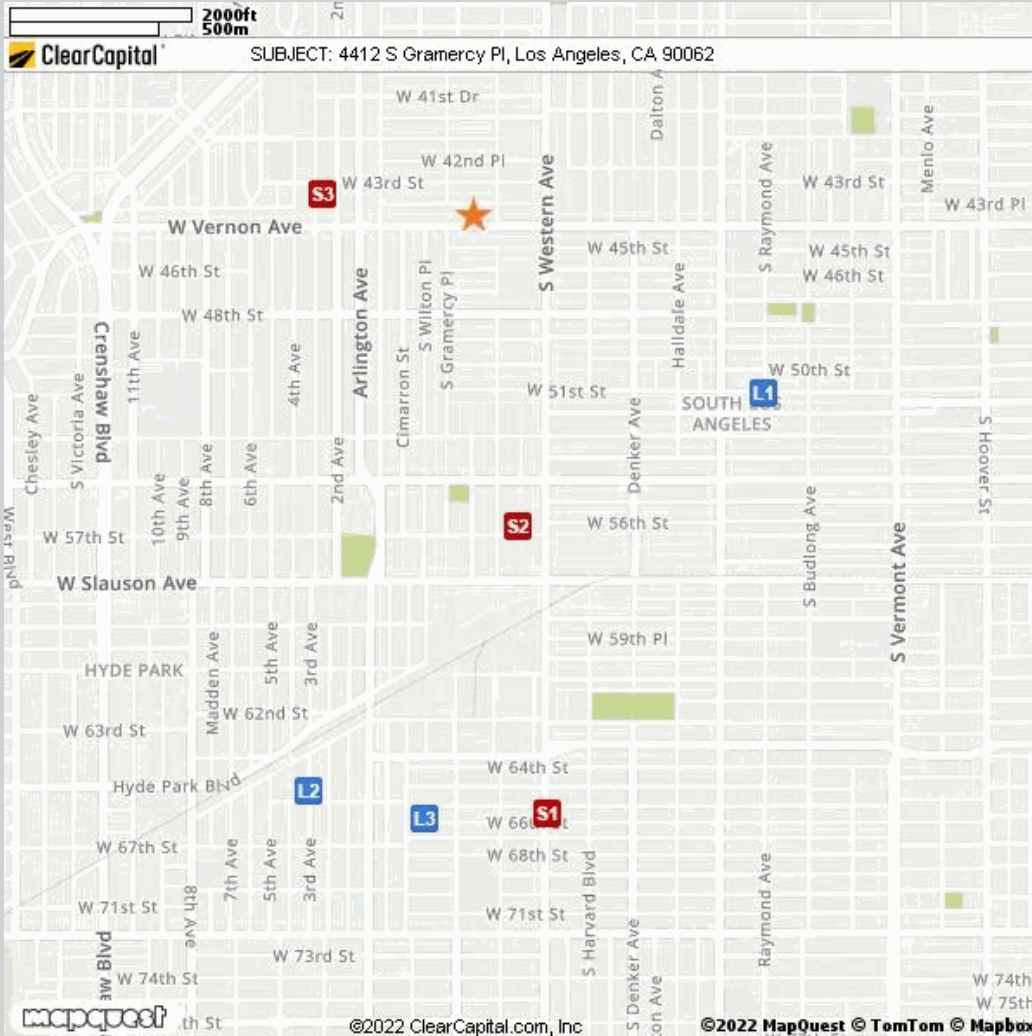
