In delivering final valuation, most weight has been placed on CS1 and LC3 as they are most similar to subject condition and overall structure.</p>

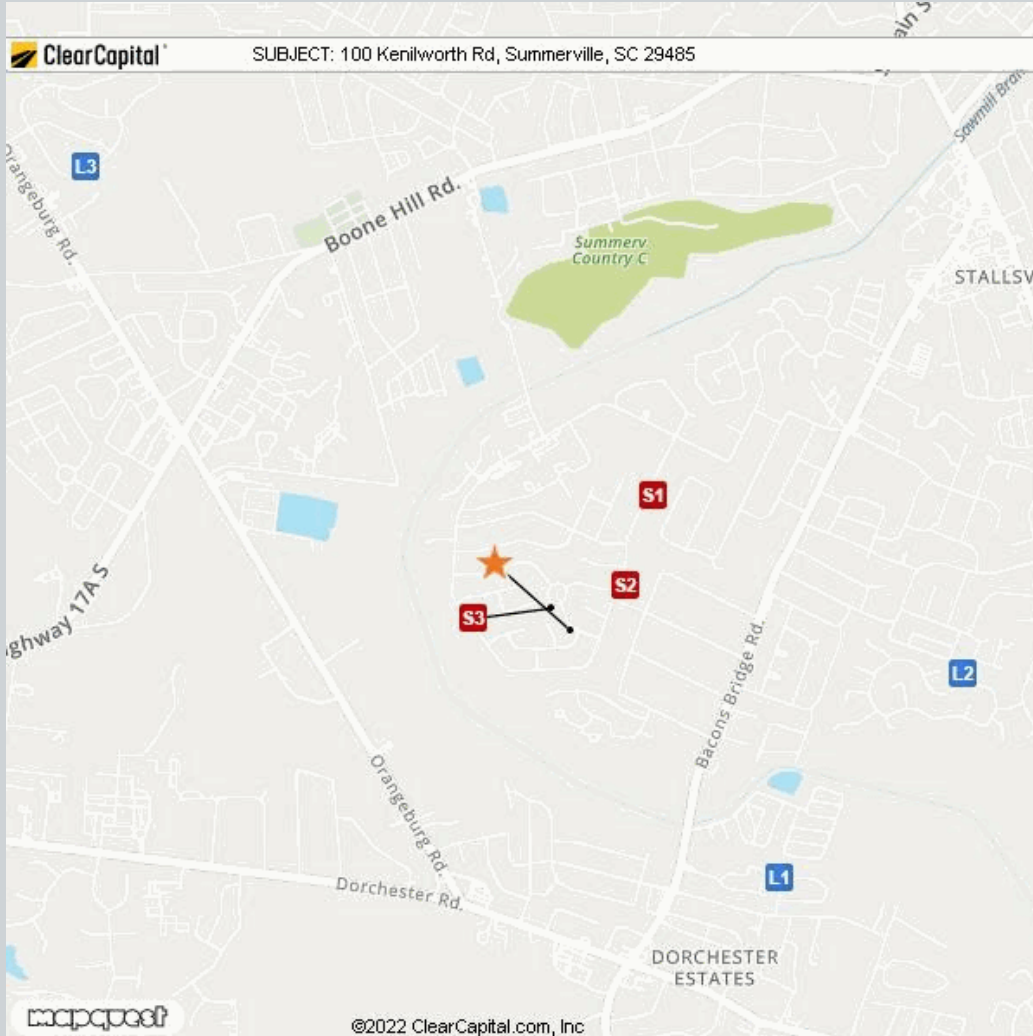
