<p>Pricing suggestion came about from analyzing the most current comps which are located as close to subject as possible and are as close as feasible in square footage, location , condition, style and acreage with subject property. I have searched a distance up to 0.5 mile, GLA +/- 20% sqft, lot size +/-30% sq ft, age +/- 20% yrs and up to 3 months in time. This was expanded to up to 12 months in time, bed bath count, gla, age, proximity upto 3.7 miles due to lack of similar homes. It was also necessary to use comparables with wider price range. Due to limited comps it is necessary to include those properties that may exceed the distance. Subject is located near freeway/highway,commercial buildings,water body,park,school however it doesnot have any impact on the value. Comps even though they are divided by the highway ,the division does not have an impact on the value.</p>

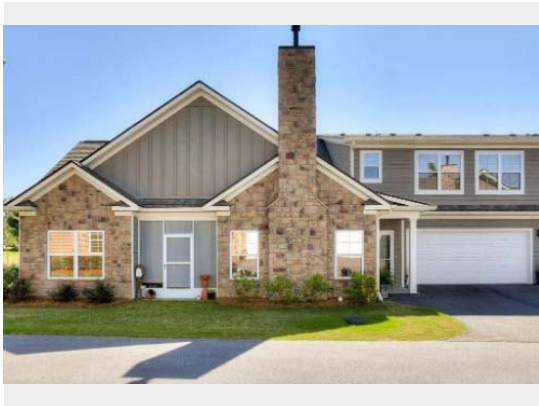

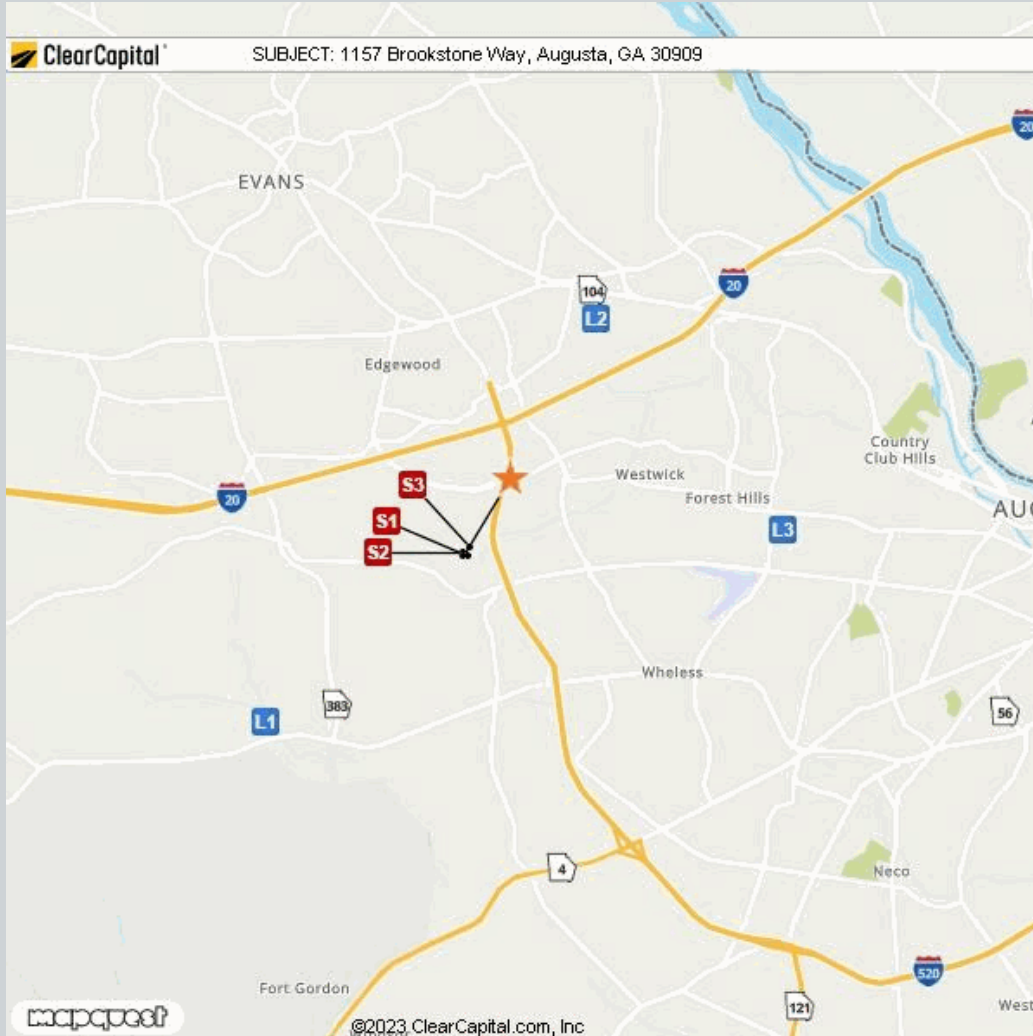
