#### **Comments Regarding Pricing Strategy**

I went back 12 months; out in distance 1 mile I was unable to find any comps which fit the subject's requirements. The ones used are the best possible currently available comps within 1 mile and the adjustments are sufficient for this area to account for the differences in the subject and comps. Limited comparables in the subject area make it necessary to use comparables with variance in 15% GLA. It was necessary to use a comparable listing (list#3) with a superior in condition due to limited market activity in the subject's area. Due to limited comps in the area, list comps were used despite not bracketing the bedroom count as they are still considered to be reliable comparables. Due to limited comps in the area, all comps were used despite not bracketing the bathroom count as they are still considered to be reliable comparables. Due to limited comps in the area, sold#2, sold#3, list#2 were used despite the over 30% lot size difference as they are still considered to be reliable comparables. At the time of sale the sold comparable #1 property may have had multiple offers or a concession was given and not noted. The BPO report must take these sales into consideration in terms of comparable selection. Due to limited comps in the area, it was necessary to use comparable with DOM not within 90 -120 days. However the 90 day price opinion would not be affected due to differing from the average marketing time. The subject is located within a reasonable proximity to water body, parks, school, worship place and commercial buildings. Comparables used in this report are from same location and neighbourhood, property's location characteristics will not affect its marketability. In delivering final valuation, most weight has been placed on CS3 and LC1 as they are most similar to subject condition. Subject's details taken from tax record. Unable to gain access to subject. 
