Comments Regarding Pricing Strategy		
<p>A limited number of comparable active listings were available within a 1 mile radius even after expanding the search criteria as follows: SqFt is 2800 to 3300 and Year Built is 1965 to 1980. As a result, it was necessary to expand the search radius beyond 1 mile in order to return the needed number of results. The final price point was determined by a carefully calculated solution between the current and sold listings with the greatest weight placed on those sold and active listings most similar in square footage and proximity. The variance in values was relatively modest while there appears to be a slight downward trend. Due to the fact that values are stable and most of the sold listings days on the market are within what's typical for this area, the final valuation will reflect a more aggressive value. The final valuation is for a fair market value set to encourage the requested marketing period for this area.</p>

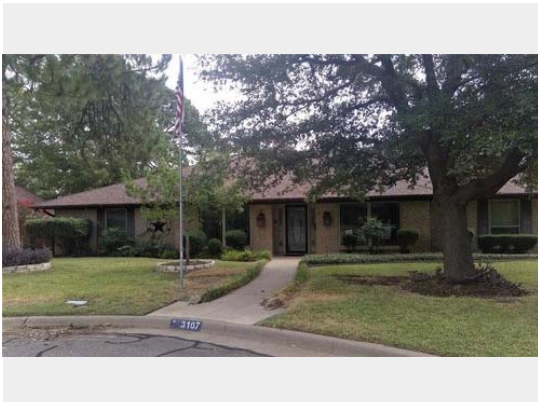

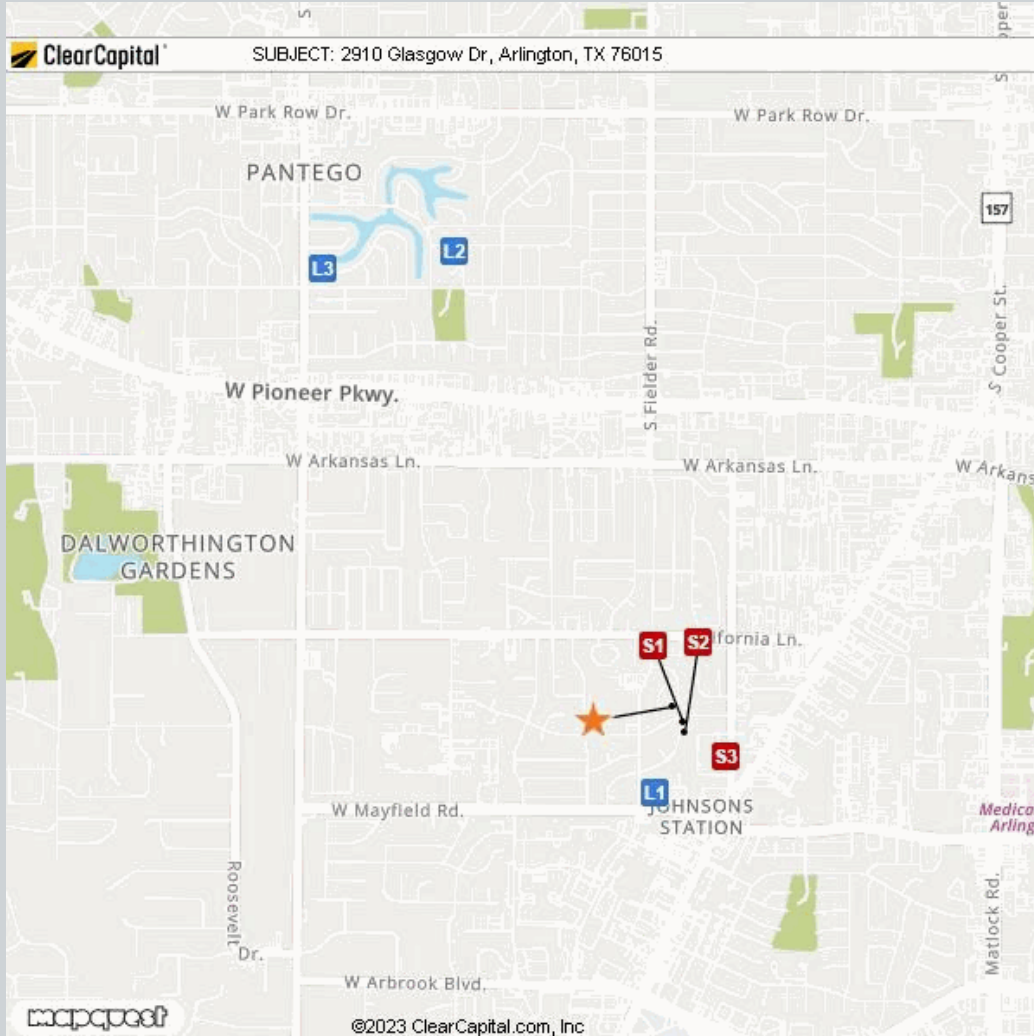
