<p>As per the recent active MLS subject si in good condition. I was required to use comparable which is sold beyond six months in order to get comparables. As there were only very limited comparable available within 1 mile, +/-30% GLA, +/-30 year built and 12 months back, the proximity parameters were expanded up to 2.1 miles. Since there were limited comparable available within subject's market neighborhood, it was necessary to exceed GLA and year built guidelines. The price range is over 25% and all sold comps are not within 15% from the subject's value due to a lack of similar comps. This variance could not be avoided and the comps were chosen for their similarities to the subject. List 1 and Sold 3 were overall most similar to the subject. Subject is located close to major roadways, educational institution and commercial area. This will have no impact on the subject's value and marketability. There was no mailbox number. Address was verified by surrounding house numbers and street sign. Subject is located behind a lot of bushes and trees, therefore no clear photo is available.</p>

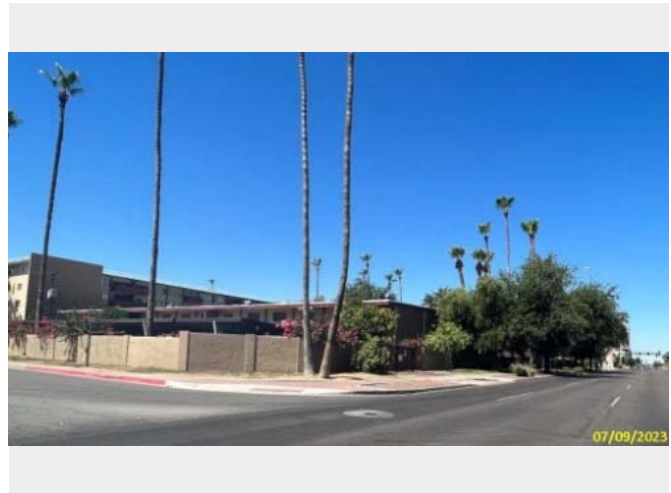

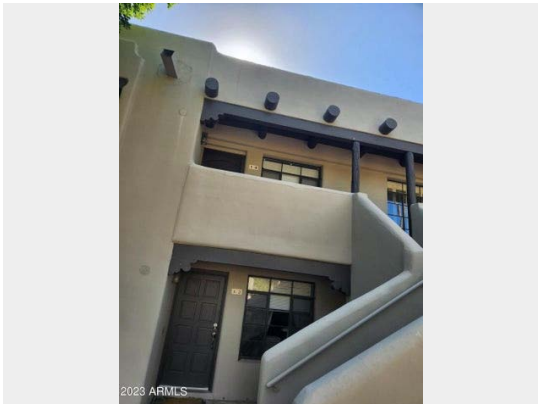

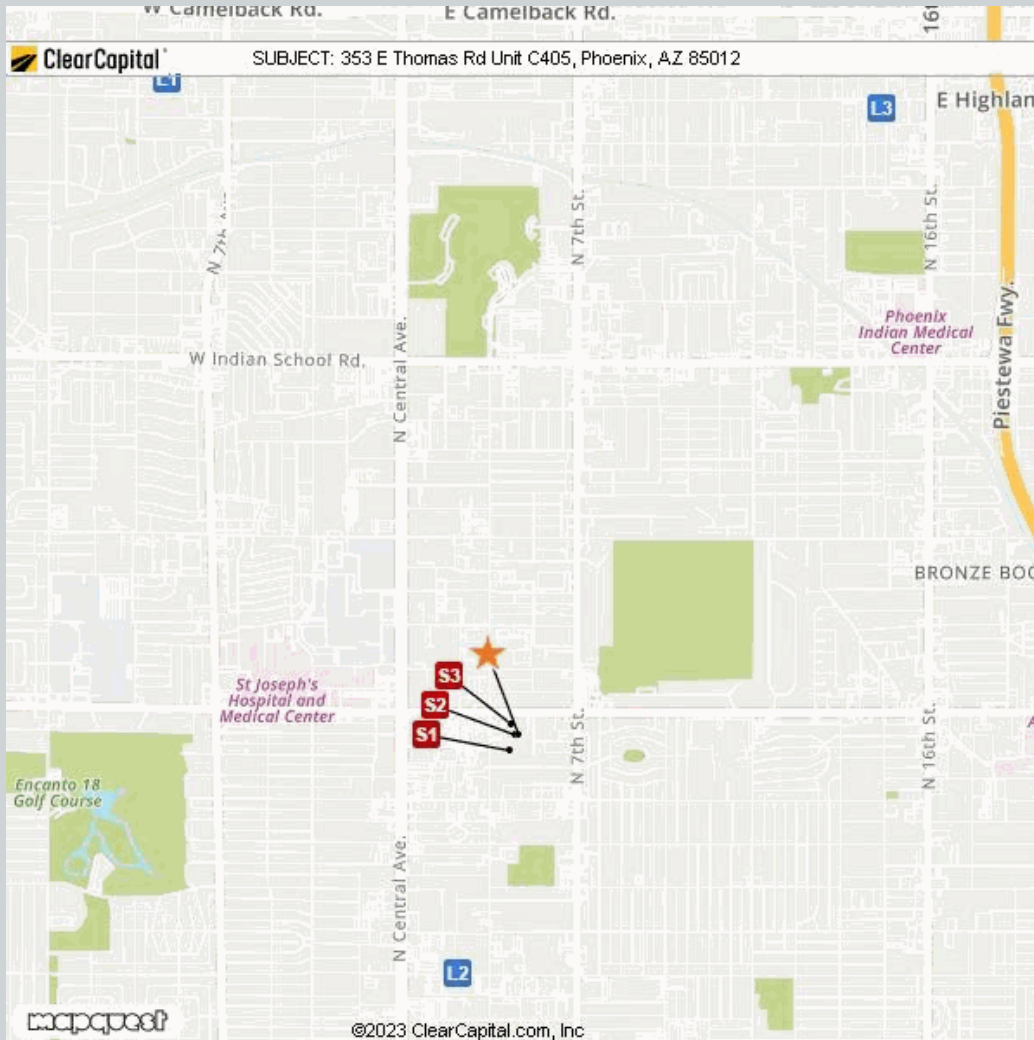
