- Sold 1** It is inferior because of having a smaller GLA and for being an older building. Overall, similar in design and appeal and has comparable views. Adjustments: \$1875 due to sq ft, -\$3026 due to the lot, \$400 due to age, and \$7500 due to TLC.
- Sold 2** Shows the best support from my value conclusion. Overall, it has the most comparable characteristics and most importantly the most similar location/view which is one of the biggest factors with the subject. Adjustments: -\$2025 due to sq ft, \$326 due to the lot, -\$1200 due to age, -\$4500 due to room count.
- Sold 3** It also has the same view as the subject, but its larger GLA, being a newer building, and updates makes this superior to the subject. Therefore my value conclusion most aligns with Sale 2. Adjustments: -\$1590 due to sq ft, \$363 due to the lot, -\$1200 due to age, -\$20,000 due to updates.

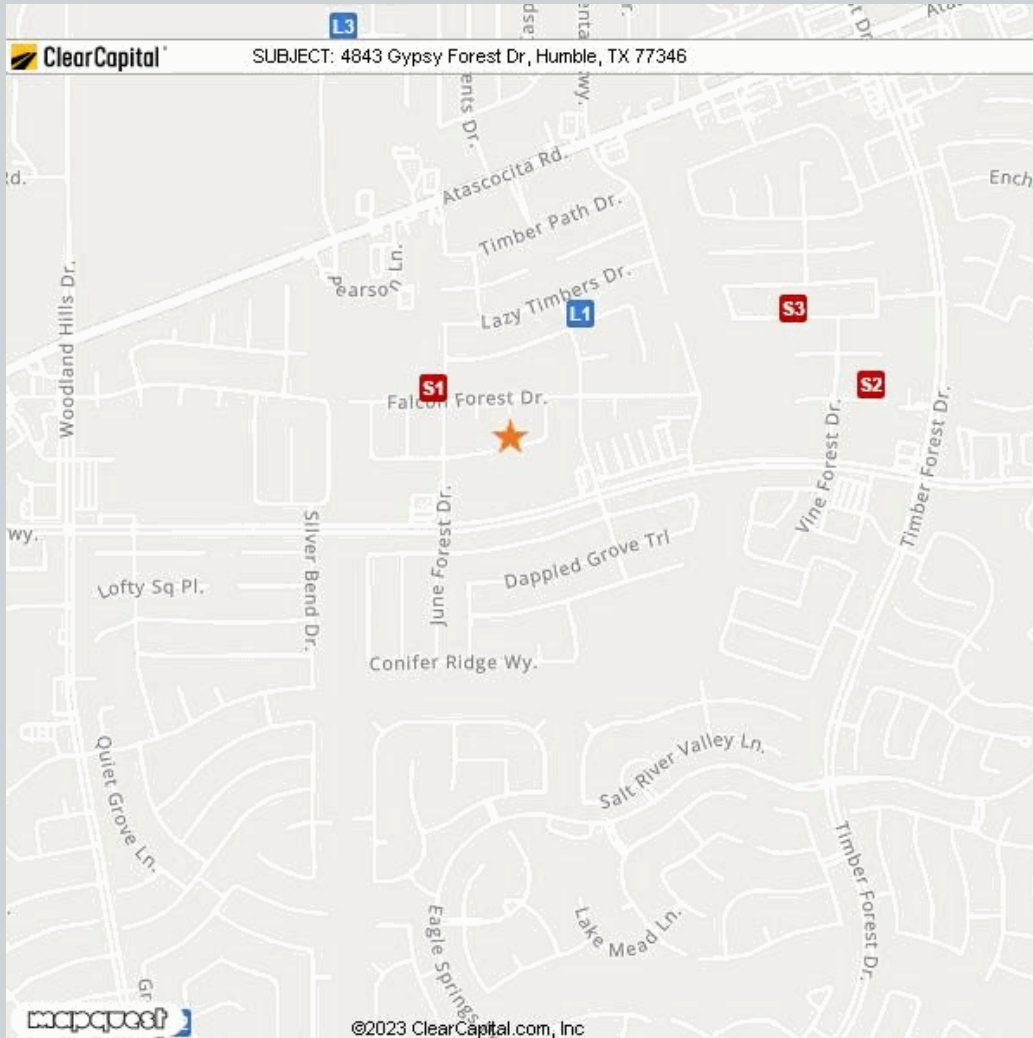
