The comparable that were closest in size, age, style, location and room count were chosen for this report. Due to limited comparable, need to exceed the condition, closed date, style, garage and lot size. Due to limited comps available, list comps were despite not bracketing the GLA since they were considered to be reliable comparables. Subject is located closer to residential, commercial, golf course and major roadways. This however, will not have effect on value and marketability. Sale 2 and listing 2 are most comparable to the subject. Their value was weighted heavily in determining the value of the subject. Subject details were taken as per tax record. Comparable(CS1) received multiple offers which resulted in an increased final sale price relative to list price.
